**PLAINTIFFS’ RESPONSE TO THE DISTRICT COURT**

Plaintiffs Taje Monbo and Deafueh Monbo (“Plaintiffs” or “Monbos”) state as follows:

1. On November 28, 2022, a notice of appeal was filed in this case. *See* Docket 219 for the appeal notice.
2. Judge Margo K. Brodie has no jurisdiction in this case as this case is in appeal. Any orders or writings by Judge Brodie are illegal.
3. Upon information and belief, Judge Brodie has accepted bribes from the Defendants in exchange for judicial favors to the Defendants.
4. Upon information and belief, Judge Brodie has accepted bribes in exchange for agreeing not to issue the mandatory request to the Register of Copyrights, which would show that Defendant Lotfy Nathan does not have a valid copyright and has infringed on Plaintiff Monbos’ copyrights and trademarks. *See* Docket 103
5. Judge Brodie has obstructed justice in this case and has abused her power. Judge Brodie has used her position as a Judge to enrich herself.
6. More importantly, Judge Brodie has been sued for \$10 million by the Plaintiffs for Judge Brodie’s illegal conduct in this case. *See* Exhibit A for a copy of the lawsuit.

7. Additionally, a Motion to Recuse was filed against Judge Brodie, asking Judge Brodie to immediately recuse herself from this case so that Judge Brodie can no longer sabotage Plaintiff Monbos' case. *See Docket 212*
