Thank you for your interest in the Hudson Valley Holistic Market. Prospective vendors must complete & submit this application. HVHM is seeking vendors who are willing to commit to the event and we understand the time and energy this takes. We jury all vendors, readers, and practitioners. *If you have spoken to Maryalyce and were advised to send this in, or if she has emailed this to you, you have already been pre-approved.* HVHM will review your application promptly & notify you as to whether there is a current opening for the goods and services you offer. If not, HVHM will keep your application on file for the future. If your application is approved, payment must be received within 5 days. Vending fees are NON-REFUNDABLE, however we **may** consider requests on a case by case basis and issue credits for future vending dates in the event of emergencies. The number of

vending spaces is limited and FEES MUST BE PAID IN ADVANCE TO SECURE YOUR SPACE. One business entity per paid space. One reader or practitioner per space. Space sharing is not permitted.

We are only accepting retailers and service providers of holistic, eco-friendly, natural, new-age and hand-crafted products and services. This includes locally grown food, herbs, honey, etc. Food vendors are required to display a health department certificate.

We are also accepting applications for readers, wellness service providers, crafters, artists and artisans. This application has information for each of our events. Note that our events may be quite diverse, so please read this application and complete the contract carefully.

For 2022, we have decided to host 5 indoor events as well as 8 outdoor events. Indoor events are held in Fishkill, NY, and outdoor events are held in Dover Plains, NY.

HVHM Management creates these events with the belief that there is enough abundance in the Universe for everyone. We are blessed to have a community that has so many healing practitioners, readers, and soul-level entrepreneurs. We expect to receive applications from practitioners who offer the same healing modalities. We will be working with each of our beloved practitioners so that we have a variety of Divination offerings and healing modalities available at our events. This should work well so that vendors are able to vend, and will also encourage us to support others within our community. We ask that you only offer the products, modalities & divinatory practices that you are approved for. We also ask that you try to keep all bags & packaging materials as eco-friendly as possible.

Due to ongoing regulations relating to the COVID-19 pandemic, we will be reviewing the rules and regulations for individual events a few weeks before each event date. As of July 1, 2021, we will be making sure that we are placing vendor tables farther apart than in the past. Other things we will be considering are the wearing of masks, distancing, and attendance regulation. We will make a final decision as to how we will be handling these details 2 weeks prior to each event and we will send this via email. We expect and request that all vendors who have signed this contract will comply with those health and safety requests.

We continue to host the best holistic vendors, practitioners, wellness centers, natural product reps, and artisans. We have holistic practitioners and some of the best readers, mediums, and psychics in the Hudson Valley.

Indoor Events:

We will be placing lunch or dinner orders with Daddy O's in Hopewell Junction. If you wish to place a food order, please have cash available. On Sundays, we order at 11am, and food arrives around 1 pm. For the evening events, we will be placing orders prior to the event date due to the Saturday dinner rush. We are happy to provide all vendors with individual receipts for your records. The Daddy O's menu can be found [here](#).

Payments for your first vending date is due when your contract is submitted. Please refer to the payment page for some earlybird discount information.

Applications and payments for indoor events are due one month prior to that event. In the event that a vendor/reader/practitioner wishes to withdraw from an event date more than 10 days before that event, you will be allowed to choose an alternate date once. Vendors/readers/practitioners who withdraw with fewer than 10 days notice forfeit that date as well as any payments made. Payments are non-refundable. In the event of inclement weather and we have to reschedule, your payment will be applied to the new date. In the event that an event you paid for is cancelled by management, your invoice will be adjusted, and if payment has already been made, you will be issued a credit which can be applied toward any event dates within 6 months of the canceled event.

Swag bags will be offered to the 1st 25 people through the door at all indoor markets. If you would like to contribute a small product, sample, coupon, etc, please get your items to Maryalyce in Wassaic no later than the dates below. Vendor space placement is pre-assigned based on needs such as request for electric access, as well as on the basis of a first-paid, first-assigned basis. No particular space logistics can be guaranteed. Reasonable accommodations can be made for those who have special needs. Please notify HVHM management in advance. I am able to make reasonable accommodation at the time your contract is submitted. **NO SWITCHING BY VENDORS WILL BE ALLOWED ON SITE!** This may change if local COVID regulations change.

Healing practitioners must advise if they are bringing equipment such as massage tables or treatment chairs, etc. If you are bringing a garment rack, massage table or treatment chair, that will count as an additional space and must be reserved as such. We are no longer accommodating surprises. When in doubt, call or email with photos.

Indoor Space Information:

Standard Space

For vendors who bring their own tables.

Size: 6' wide x approx 3.5' deep

Tables: Vendor responsible for bringing tables & linens. Tables may NOT exceed standard 6' x 30" table size. Garment racks, massage tables, zero gravity chairs, racks that are independently standing and do not fit on your 6' table, AND THE LIKE will need an additional space. This also includes easels and large independently standing pop-up shades. If you require or prefer an L-Shaped display, please reserve a second space and note your requirement on the application.

Includes: 2 chairs provided for each vendor, listing on social media event, spotlight on social media pages, link on HVHM website, and includes the vendor breakfast for 1 person during the Holiday Market only.

Upgraded Space

For vendors who need a table or who prefer to have a table on site.

Size: 6' x approx 3.5' deep

Tables: HVHM will provide one (1) 6' standard size table. Garment racks, massage tables, zero gravity chairs, racks that are independently standing and do not fit on your 6' table, AND THE LIKE will need an additional space. This also includes easels and large independently standing pop-up shades. If you require or prefer an L-Shaped display, please reserve a second space and note your requirement on the application.

Includes: 2 chairs provided for each vendor, listing on social media event, spotlight on social media pages, link on HVHM website, **PLUS the table** for that event. Includes the vendor breakfast for 1 person during the Holiday Market only.

Limited quantity of 12 tables to be allocated per event, limited to 2 per vendor.

Please note that we have a Vendors Only Shopping Hour back during our Holiday Market in December, and also have a Vendor Breakfast. This is an extra hour to allow vendors to jingle & mingle, patronize other vendors, get some of their own holiday shopping done, squeeze in some network marketing, and enjoy each other's company.

We will be opening load-in at 7:30am, and serving a light buffet breakfast from 8:00-9:30am. Vendors, readers, and practitioners are asked to be **fully set up by 9am** for the vendors-only shopping. We open to the public at 10. It would be very appreciated if you can offer "vendor specials" during that time. You are welcome to barter with one another as well. This is something fun that we are adding. Cost for this event includes 1 breakfast ticket. Breakfast will include a hot and cold buffet, coffee, tea, and assorted juices. Additional tickets are available for \$15/ea if you have vending assistants who are coming with you.

Our Vendor Breakfast will be provided by a local business that is approved by the venue. We will be emailing a menu once we secure that provider. Please return that menu to us by the date indicated at that time. One breakfast package is included in your vending fee. Additional breakfast packages will be available for a separate fee.

Outdoor Events:

Outdoor vending events will take place on the second Saturday of the month from April through November. Load-in begins at 8:30am and events run from 10am – 3pm. You may choose to remain set up until 5pm at no extra charge during these outdoor event dates since that is the close of the business day for Akasha's Journey.

Outdoor events are weather-permitting, and we can accommodate a small number of vendors inside (three 6-foot tables fit in our hall and I have space for up to 2 readers). We also allow vendors to set up during any day and time that is within Akasha's Journey's normal operating hours for the same fee. Please contact Maryalyce for more information if that is an opportunity that you would like to take advantage of.

We are accepting retailers and service providers of holistic, eco-friendly, natural, new-age and hand-crafted products and services. This includes locally grown food, herbs, honey, etc. Food vendors are required to display a health department certificate. We are also accepting other local vendors, artisans, crafters, and direct sales for outdoor markets in order to foster and encourage other businesses in our area.

We will allow ONE vendor per type at each event. We almost always have room for more vendors.

Products offered must not be currently stocked at Akasha's Journey. Please familiarize yourself with the products and services already offered there prior to sending in your application. www.akashajourney.com The following are already covered: CBD products, Doterra, Young Living, crystals, Barefoot Books, loose herbs, and teas. *Reiki, massage, and readers are by invitation only.* Payments for your first vending date is due when your contract is submitted. Outdoor Space Information:

Spaces are outside in the parking lot and along our sidewalk & grass. Each vendor will be assigned a space that will accommodate a 10'x10' awning. Vendor spaces will be assigned to allow proper social distancing. Vendors will be required to follow any state and local regulations regarding social distancing, PPE, and hygiene requirements for businesses.

The cost for a 10x10 space is \$20 per day. Spaces are outside during our normal operating hours. There is no electricity available for events in Dover Plains.

Vendors who will be with us are encouraged to post as such on their social media accounts and mailing lists.

Vendors are responsible for bringing their own awnings, weights, tables, chairs, table covers and displays. No call/no show vendors will not be allowed to vend subsequent events & forfeit their fees paid.

Earlybird Discounts:

An "earlybird discount" of \$10 per INDOOR event will be applied to all applications received **and paid in full** by 1/1/22. Reserve all 5 events and pay in full by 1/1/22 and take \$55 off your total.

An "earlybird discount" of 10% off the total will be applied to vendors who choose to attend all OUTDOOR event dates. Vendors must sign up for all 8 event dates and pay in full no later than 1/1/22.

Late Fee:

A \$5 late fee will be assessed for applications and/or payments that are not received by the event due dates.

Applications, contracts, and payments are due 5 days prior to the outdoor event taking place. Vendors/readers/practitioners who withdraw with fewer than 10 days notice forfeit that date as well as any payments made. Vendors/readers/practitioners who must withdraw from the event giving more than 14 days notice may be issued a credit at the discretion of management. That credit would be applicable for any event(s) occurring within 6 months of the cancellation. This is a situation that will be solely at the discretion of management. Payments are non-refundable. In the event of cancellation due to inclement weather, any payments already made will be applied to an alternate date and event of the vendor's choice.

TOTAL AMOUNT FOR ALL EVENTS (INDOOR + OUTDOOR): \$ _____

BY COMPLETING THIS APPLICATION AND SIGNING THE AGREEMENT, THE VENDOR AGREES TO:

- Print & distribute at least 25 copies of our official flyer or post cards. We would love for you to print flyers if you are able. This helps both you and the market. Please also feel free to share these via email to your lists, social media pages, etc.
- Begin setting up the exhibit no later than 1 hour prior to the opening of the event. Please note that if you are not ON SITE 1 HOUR PRIOR TO OPENING and we have received no phone call from you that you will be running late, your space may be assigned to another vendor on our wait list.
- **(INDOOR EVENTS):** All vendor supplied tables must not exceed a standard 6' x 30" table size. Spaces are 6' wide with enough space for your chairs to fit comfortably behind. The exception to this is for those who reserve Premium 10x10 spaces. We have seen an increase of people bringing two 4' tables or additional smaller side tables. Going forward, you will be charged for these if they extend the length of your space and encroach on the space we have allotted for you or your neighbor. We will attempt to make space for your additional furniture at the event, but you will be charged for the extra space either on site or via separate invoice after the event concludes. We will NOT disrupt spaces that we have set for you and your vendors because you have brought displays that you have not informed us about. If you have any questions, please send us a picture of your setup prior to submitting this contract and we will be happy to discuss this **before an event**.
- **(OUTDOOR EVENTS): Vendors are responsible for bringing their own awnings, WEIGHTS, tables, chairs, and displays.**
 - **Awnings must be weighted down.**
- We would like to resume our morning intention affirmations before each event. You are welcome to join us a half hour before each event to set intentions for the day.
- Remain set up for the entire length of the event unless otherwise advised by Hudson Valley Holistic Market Management. You should be set up no later than 9am for Vendor Hour, and may not begin packing up until the close of business at 5pm. Vendors agree to be completely broken down by 90 minutes after the market closes. Vendors who strike their setups early will not be welcome back to future events.
- Cooperate in and around the gathering of trash around your space.
- Withdraw any material found objectionable by the Market.
- Sell ONLY THE PRODUCTS AND SERVICES APPROVED by management on the application.
- If a vendor has products not listed on the application that are in conflict with nearby vendors, the Market may ask that the products be removed. (This will be enforced).

- DO NOT bring loud speakers or PA systems without prior approval.
- DO NOT create your own Facebook event for any of our market dates. Please share our official events & invite your friends, family, and clients through our page and events. We sponsor each of our events and we also post all updates there. Any unofficial events will be reported to Facebook as a violation of intellectual property until they are removed by their creator.
- Indemnify, defend and hold harmless Maryalyce Merritt, the Hudson Valley Holistic Market, Akasha's Journey, Comfort Inn and Suites, Dover Village, LLC, its agents, officers, employees and representatives for all claims of bodily injury, property damage and bodily injury including all consequential financial loss resulting therefrom as well as all legal expenses involved in handling such claims.
- Collect and pay all municipal state and federal taxes related to all sales made.
- THE VENDOR AGREES TO PAY A NON-REFUNDABLE SPACE RENTAL FEE, TO BE REMITTED IN FULL WHEN SUBMITTING THIS CONTRACT.
- HVHM Vendors are required to provide copies of all licenses and/or permits necessary to the types of products you are planning to sell: i.e., Board of Health permits, nursery license, authorization to collect sales tax (if your business is required to do so).
- Children are welcome at our marketplace, but must be well-behaved and engaged in safe behavior. Vendors who bring their child(ren) must remain actively engaged in their supervision at all times. Child(ren) must be directly supervised by their parents during the hours of the marketplace including setup and breakdown. No running, rough play, yelling, harassing vendor neighbors, or other inappropriate behavior, ESPECIALLY those behaviors that disturb market vendors, attendees, staff, etc. This includes other creative forms of inappropriate behavior. HVHM management reserves the right to speak to your child and to you to manage any adverse situations that are occurring at any event. Should management need to intervene more than once, you and your child(ren) may be asked to leave that event and you forfeit your ability to bring your child(ren) to any future events.
- HVHM management requires vendors to attend the date that they commit to unless the vendor notifies HVHM management when submitting application or contacts the market manager if an emergency occurs. No call/no show vendors will not be allowed to vend subsequent events & forfeit their fees paid.
- Vendor agrees to operate their booth in a safe and courteous manner.
- Vendor agrees to bring positive energy to the event.
- Vendor agrees to refrain from bringing any drugs and illegal substances onto Comfort Suites and/or Dover Village, LLC properties including their own vehicle, which may be parked on the premises.

- Vendor agrees that if they do not notify management & fail to show for an event, they forfeit my right to vend at all other HVHM and Akasha's Journey events and also forfeit any moneys paid.
- Vendor understands that failure to comply with the rules and regulations could result in dismissal from the market.
- Vendor understands the booth size and hours of operation are determined by the market's management and even if you do not agree with them, you will abide by them.
- Vendors are responsible for enforcing COVID-19 protocols as they pertain to your business and your customers while on our premises.
- HVHM management may request that vendors wear masks during events regardless of individuals' vaccination status. Management will inform vendors via email within 14 days of the event, as this decision may change as we get farther away from pandemic status of 2020.
- Vendors must provide hand sanitizer at their booth for themselves and customers

Readers and Healing Practitioners

- Understand that as an approved healer/reader, you may be approved and scheduled to offer specific modalities only during the Market. You agree to only provide the modality/divination type that is agreed upon between myself & HVHM Management.
- All new (to us) readers must submit 3 references and may be asked for a sample reading.
- All readers & practitioners will need to email a bio & picture along with the length of your sessions and what you charge. We make every attempt to accept pre-booked appointments for you and that will be done by the Market. You will, however, accept your own payments. HVHM does not ask for a percentage of your income from our events.
- Any practitioner who is offering in-person sessions will be required to practice in a safe manner and follow guidelines at least for licensed massage therapists. This is including, but not limited to:
 - Making sure clients wear a mask as State or Local regulations require
 - Practitioner must wear a mask as State or Local regulations require
 - Use of clean sheets as well as cleaning equipment between each client.
 - Having clients complete additional COVID-19 Questionnaire prior to treatment if State or Local regulations require
 - Taking client's temperature prior to treatment if State or Local regulations require
 - You are required to provide your own thermometer, clean linens, etc.
- Your clients will be required to follow State and Local regulations regarding the wearing of masks and social distancing during a reading.
- Please discourage clients from placing their hands directly on your cards or divination tools
