

## SVIIF GENERAL INSTRUCTIONS

- 1- The Silicon Valley International Invention and Innovation Festival is open to inventors, companies, firms, promoters, associations, universities, private and state organizations showcasing inventions that are already protected by intellectual property rights.
- 2- An invention can only be presented once at the Santa Clara Exhibition, unless significant modifications have been made to it since its initial display.
- 3- Inventions may be presented in the form of pre-series or commercial samples, already manufactured articles, prototypes, models, plans, drawings, photos, and texts.
- 4- The exhibited inventions will be categorized by country. Exhibitors are required to specify the type of stand they require on the entry form. The Committee will allocate stand locations.
- 5- Exhibitors may not sell products or articles directly to visitors. However, the sale of products or articles is authorized in a special section of the exhibition. For information, apply to the secretariat.
- 6- Exhibitors are required to fill out a separate entry form for each invention they intend to exhibit. Each form should include information for only one invention. Completed and signed entry forms should be submitted to the Secretariat as soon as possible and before the deadline.
- 7- Upon acceptance of the Entry Form and confirmation of registration by the Committee, exhibitors are required to promptly settle the total amount specified in their invoice within the stipulated timeframe. Exhibitors opting to cancel their participation before the final registration date are subject to a 50% payment obligation. In the event of cancellation after the last registration date, exhibitors must remit the entire amount specified in their invoice.
- 8- Exhibitors Exhibitors in need of services such as electricity supply, furniture, parking, or advertising space in the Official Catalogue must submit their requests using the designated forms. These forms will be provided to exhibitors within the specified deadline and are accessible on sviif.com.
- 9- Exhibitors Upon receiving the Entry Form, the Committee will dispatch General Instructions to each exhibitor. These instructions will cover details such as: Dates for the construction and dismantling of stands, Guidelines for sending and/or transporting inventions, Information on the official opening ceremony of the Exhibition, The day designated for the International Jury to evaluate each invention and Details about the prize-giving ceremony
- 10- The Committee bears no responsibility for errors in the translation or wording of descriptions and advertisements published in the Official Catalogue. A security service will be in operation throughout the entire duration of the Exhibition.
- 11- The Organizing Committee and its representatives abroad disclaim any responsibility for loss, theft, damage due to fire or other causes, or personal injury suffered during the Exhibition or in transit.
- 12- Through their formal application to participate in the Exhibition, each exhibitor commits to delivering their invention at the specified time according to the instructions received and agrees to keep it on display for the entire duration of the Exhibition. Any exhibitor withdrawing their invention before the exhibition's closure will be held liable for damages and will forfeit any awards granted to them.
- 13- The applicant assumes full responsibility for completing this application, signifying that they have obtained permission from the owner(s) of the invention(s) to fill out this entry form.
- 14- The IFIA, the Organizing Committee, or any member of the Silicon Valley International Invention Festival (SVIIF) Steering Committee disclaim any responsibility for the outcomes or lack thereof regarding a participant's results and involvement in the event.
