- Upload: One print-ready artwork file for the roll-up stand (PDF format preferred)
- Orientation: Vertical / Portrait
- Final Size: 24 inches (Wide) x 80 inches (Height)
- Resolution: High-resolution output recommended (minimum 150–300 DPI)

#### Roll-Up Stand Design Guidelines (Applicant-Prepared Artwork)

- Title of the Invention / Innovation
- Applicant / Organization Name
- Country
- Brief Description of the Invention (clear, practical, and easy to understand)
- Up to three (3) images or illustrations demonstrating the invention, concept, or application
- Key features or practical benefits of the invention (bullet points recommended)
- Contact Information of the Applicant, including:
  - Email address
  - Phone number (with country code, if applicable)
- Optional: Website or QR code (if available)

### General Instructions - Online Participation (Non-Attending Exhibitors)

- 1. Eligibility and Scope:** The Online Participation category of the Silicon Valley International Invention & Innovation Festival (SVIIF) is open to individual inventors, companies, organizations, universities, and institutions that are unable to attend the event in person. This participation mode allows applicants to showcase their invention or innovation remotely through an on-site exhibition display stand prepared and installed by the Organizing Committee.
- 2. Online Participation Format:** Online participants will not be provided with a physical exhibition booth. Instead, each accepted invention will be presented at the exhibition venue using a vertical display stand with dimensions of 24 inches (width) × 80 inches (height). The stand will be produced and installed by the organizer based on the materials submitted by the participant.
- 3. Originality and Previous Participation:** Each invention may be presented only once at the SVIIF exhibition, unless it has undergone significant modifications or development since its previous presentation. The applicant confirms that the submitted content accurately represents the invention or innovation.
- 4. Forms of Presentation:** Online participants may present their inventions in the form of:
  - Printed visual presentations displayed on the exhibition stand
  - Descriptive texts, diagrams, images, and graphics
  - Supplementary digital materials submitted for jury evaluation
 Physical prototypes or products are not required for online participation.
- 5. Categorization:** Exhibited inventions will be categorized by country and technical classification. The Organizing Committee reserves the right to reassign the category of an invention if deemed necessary.
- 6. Entry Forms and Submissions:** A separate online entry form must be completed for each invention submitted under the Online Participation category. All required information, documents, and display materials must be submitted before the announced deadline. Incomplete submissions may not be accepted for evaluation or display.
- 7. Non-Commercial Exhibition Policy:** Online participation is strictly non-commercial on site. Online exhibitors are not permitted to sell products or conduct direct commercial transactions during the exhibition. Any commercial discussions, if applicable, must take place outside the exhibition floor and independently of the event.
- 8. Fees, Registration, and Cancellation:** Upon acceptance of the Online Entry Form, the applicant is required to settle the applicable participation fees within the specified timeframe.  
Cancellation policy:
  - Cancellations before the final registration deadline may be subject to partial charges.
  - Cancellations after the final registration deadline may result in full charge, according to SVIIF policy.
- 9. Display Materials and Artwork Submission:** Online participants must submit print-ready artwork files for the exhibition stand according to the technical specifications provided by the Organizing Committee. By submitting the files, the applicant confirms that:
  - All content is final and approved for printing
  - Names, titles, and descriptions are accurate
  - The organizer may apply minor technical adjustments (e.g., margins or bleed) without altering the content
- 10. Technical Services and Limitations:** The standard display stand installation is included in the Online Participation package. Any special requests must be submitted in advance and are subject to availability and additional charges, if applicable. On-site modifications during the exhibition are not guaranteed.
- 11. Jury Evaluation:** Evaluation and judging will be conducted by the official International Jury based on the submitted materials, including the display content and supporting documents. At the discretion of the Jury, online interviews or virtual presentations may be requested.
- 12. Accuracy of Information and Security:** The Organizing Committee bears no responsibility for errors in the wording, translation, or content of materials submitted by online participants. General exhibition security will be provided; however, the Organizing Committee assumes no responsibility for damage or loss related to submitted materials.
- 13. Liability Disclaimer:** The IFIA, the Organizing Committee, and their representatives disclaim any responsibility for loss, damage, or injury arising during the exhibition or in connection with online participation, except as required by applicable law.
- 14. Display Commitment and Withdrawal:** By submitting an Online Entry Form, the applicant agrees to allow the submitted display materials to be exhibited for the full duration of the festival. Any withdrawal after confirmation of participation may result in disqualification from evaluation and recognition.
- 15. Evaluation Results and Disclaimer:** Participation in the Online Participation category does not guarantee awards, rankings, partnerships, or commercial outcomes. The Organizing Committee shall not be held responsible for the results or lack thereof resulting from participation in the event.
