**Youth Innovation Category – Introduction**

- The Youth Innovation Category of the Silicon Valley International Invention & Innovation Festival (SVIIF) is designed to encourage creativity, curiosity, and innovative thinking among children and teenagers aged 7 to 18.
- This category focuses on ideas, learning, creativity, and early-stage innovation. Participants are invited to present their concepts, projects, models, drawings, prototypes, or educational inventions in a supportive and educational environment.

**Intellectual Property Notice**

For the Youth Innovation Category, patent registration is NOT required. This exception exists because young innovators are often in the early stages of learning, experimentation, and idea development. The purpose of this category is education, inspiration, and encouragement, rather than commercialization or technology transfer.

Please note:

- Participants and their parents/legal guardians are responsible for the content they choose to disclose.
- It is recommended not to submit highly confidential or commercially sensitive details.
- All submitted projects are evaluated solely for educational, creative, and innovative merit.
- The Youth Innovation Category is a non-commercial, educational, and inspirational section of SVIIF.
- No sales, licensing, or commercial negotiations are permitted for youth participant

**Evaluation and Judging Process**

Evaluation and judging in the Youth Competition will be conducted exclusively within defined youth age categories, ensuring a fair, age-appropriate, and educational assessment process for all participants.

Participants may present innovative ideas, creative concepts, educational projects, models, prototypes, or early-stage developments that reflect originality, problem-solving skills, and imaginative thinking. Submissions will be evaluated based on criteria such as creativity, clarity of presentation, educational value, originality, and relevance to the participant's age group.

Youth participants who achieve the required evaluation score, as determined by the official jury, will be awarded official Youth Section Certificates and Recognition Awards in acknowledgment of their creativity and innovation.

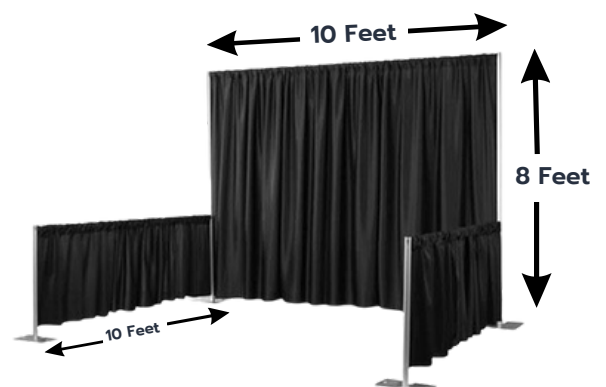

## **Youth Section – General Instructions**

### **1. Eligibility and Scope**

The Youth Section of the Silicon Valley International Invention & Innovation Festival (SVIIF) is open to children and teenagers aged 7 to 18, participating as individual youth innovators. This section is educational, non-commercial, and inspirational. Participation requires parental or legal guardian consent.

### **2. Originality of Projects**

Each project may be presented only once unless it has undergone significant development. Projects must reflect the participant's own creativity appropriate to their age group.

### **3. Forms of Presentation**

Projects may include drawings, models, prototypes, educational projects, concept explanations, or simple software and games.

### **4. Categorization and Display**

Projects are categorized by age group and country. Display areas are assigned by the Organizing Committee using educational display formats.

### **5. Entry Forms**

A separate entry form is required for each project and must be signed by a parent or legal guardian.

### **6. Non-Commercial Nature**

The Youth Section is strictly non-commercial. No sales or commercial negotiations are permitted.

### **7. Fees, Registration, and Cancellation**

Registration fees, if applicable, must be handled by parents or guardians. Cancellation policies apply as announced.

### **8. Services and Special Requests**

Requests for electricity, furniture, or display support must be submitted using official forms.

### **9. General Instructions and Schedule**

Participants will receive instructions regarding schedule, setup, evaluation, and awards.

### **10. Accuracy of Information and Security**

The Organizing Committee is not responsible for translation errors. General security will be provided.

### **11. Liability and Safety**

IFIA and the Organizing Committee are not liable for loss, damage, or injury. Parents are responsible for supervision.

### **12. Display Commitment**

Projects must remain on display for the scheduled duration unless approved otherwise.

### **13. Parental Responsibility and Consent**

Parents or guardians confirm permission and responsibility for participation.

### **14. Evaluation, Awards, and Disclaimer**

Judging is conducted within age groups. Certificates and recognition awards are granted to qualifying participants.
