Conditional Use Application, **C-24-006**, for a for a 450' tall, lit, guyed communication tower in a 100' x 100' leased area on private property **has been withdrawn.** The application was filed by **VB BTS II**, **LLC (Agent: Mike Bieniek)** at 2958 Fernberg Road, Ely, MN 55731.
