



## Glen Laurel HOA 2026 Pool Season

The Glen Laurel HOA pool will open beginning **Saturday, May 23, 2026** and access to the pool will now be available to Glen Laurel residents that have registered and obtained the 2026 Glen Laurel wristbands. Each household that is current on the HOA dues and have completed the pool registration form will receive up to **6 RED wristbands for the season** once the criteria noted above is verified. There will be a flat \$5.00 charge to obtain these wristbands. Each Glen Laurel resident and guest must have a **red** wristband to access the pool. Lost/replacements wristbands may be purchased for a flat \$10.00 charge per wristband at the management office.

Please see attached the pool registration form, provide the requested information, and submit pool registration form. **\*\*Please note: the GL plastic pool tags are now be considered INVALID.\*\***

**RENTERS:** Residents will be required to show proof of residency, i.e. state issued id, utility bill, and their current lease agreement to obtain wristbands.
