ARTICLE V

PURPOSE AND POWERS OF THE ASSOCIATION

This Association does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide for maintenance, preservation and architectural control of the residence Lots and Common Area within those certain tracts of property included within the <u>Glen Laurel</u> subdivision in Fort Bend County, shown on plats of

record filed in the Office of the County Clerk of Fort Bend County, Texas recorded on Slides 1745 A & B and 1746 A & B of the Plat Records of Fort Bend County, Texas; and to promote the recreation, health, safety and welfare of the residents of the above described subdivision.

ARTICLE VI

BOARD OF DIRECTORS

In the event dedication is not accepted, assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust of other organization to be devoted to such similar purposes.
