The Burney Road MUD has completed the new building and we are now holding all MUD and HOA meetings at the new building. We are excited to have this new amenity in our community. As a reminder this building was financed by the Burney Road MUD, but the property is owned by the HOA. The HOA has entered into a lease agreement of its land to the MUD and upon expiration of the lease will have the right of first refusal to purchase the building before the MUD dissolves. The building is now available for rent for parties and or events at a fee to Glen Laurel residents. After 13 years the HOA has begun the 3rd and 4th phase of the Glen Laurel wall project. INOPERABLE VEHICLES ARE A NUISANCE

The Texas Transportation Code Chapter 683, sets guidelines passed by the State Legislature. The City of Sugar Land and Glen Laurel HOA uses the guidelines set by the state in the Texas Transportation Code (TTC) to ensure that all vehicles are legally operable and not abandoned.

"Inoperable vehicle" shall mean any vehicle, whether a motor or non-motorized vehicle and as defined within this section or the Texas Transportation Code, which cannot be operated on the public roadway due to lack of current registration or physical condition, in accordance with all applicable state laws and this Code.

This ordinance also requires that the vehicles either be made legally operable, garaged or removed from the city limits. Although these are not the primary concerns of the ordinance, this ordinance prevents inoperable vehicles from becoming permanent fixtures in a neighborhood, residential junkyards, or creating an aesthetic nuisance of which all diminish the integrity, development, and value of the neighborhood.

We have noticed several homes in the neighborhood with inoperable vehicles parked on the public street or in their driveway. Please take the time to address this matter if you have an inoperable vehicle. Glen Laurel HOA will continue to enforce our rules and regulations regarding inoperable vehicles. Avoid receiving a pesky violation letter by parking your inoperable inside your garage or make it operable.

GLEN LAUREL DECLATION OF COVENANTS, CONDITONS AND RESTRICTIONS Section 9: Storage of Vehicles. No trailer, inoperable automobile, camper, boat, commercial use truck, or self propelled or towable equipment or machinery of any sort or any item deemed offensive by the Board of Directors will be stored, parked, or kept on any Lot or in the street in front of the Lot except in an enclosed structure or behind a solid fence. No Owner of any Lot or any guest of any Owner shall be permitted to perform work on automobiles or other vehicles in driveways or streets other than work of a temporary nature not exceeding forty-eight (48) hours.

PLEASE REMOVE AND STORE CHRISTMAS DECORATIONS **AND LIGHTS**

Residents, we still have homeowners that have their Christmas lights up. This is a reminder to please remove and store all Christmas lights and decorations, to be put up in December. The Glen Laurel ACC Guidelines state the following: Seasonal decorations must be removed within 4 weeks after the holiday and can not exceed 6 weeks in duration.

PLEASE OBTAIN ACC APPROVAL BEFORE MAKING CHANGES TO THE EXTERIOR OF YOUR HOME

The Board would like to remind residents that any and all exterior modifications to your property need to be submitted to the Architectural Control Committee (ACC) to be reviewed and approved prior to construction. This is done to comply with the guidelines set in our Architectural Guidelines and the Declaration of Covenants. The documents to review and the form to submit to the Architectural Control Committee can be found on our website in the DOCUMENTS tab. TRASH PICK UP GUIDELINES

Collection days are **MONDAY** and **THURSDAY** for garbage and **MONDAY** for recycling and green waste. When regular pick-up falls on the holidays of Thanksgiving, Christmas and New Year's, the pick-up will be made on the next day. All other holidays have normal pick up. Please secure all garbage in the grey garbage cart containers and the recycling in the green cart provided by Republic Services.

If you need to obtain a replacement cart, please call Republic Services at 713-726-7300. Set your cart out by 7:00 a.m. on your collection day but no earlier than 6:00 p.m. the evening before. Carts should be placed at least 3ft apart to ensure the collection trucks can service both carts. Make sure to store your garbage carts inside your garage or behind your fence line at all times; they must be stored out of public view by 8:00 a.m. the morning following pick-up.

Bulky Waste Collection Guidelines

Bulky waste service is provided on a routine schedule on the first Monday of each month. The City offers 3 additional bulky waste collections following the Thanksgiving, Christmas, and New Year's holidays at no additional cost.


- · Set bulky items out by 7 a.m. on your collection day but no earlier than 6 p.m. the evening before.
- · Residents may place up to five cubic yards of bulky waste out for collection on their bulky waste service day.
- · Do not place items in garbage carts for bulky waste collection. Items should be placed directly at the curb.

Green Waste Program Guidelines

- · Set your green waste out by 7 a.m. on your collection day but no earlier than 6 p.m. the evening before. No more than 10 cubic yards will be collected.
- · Loose materials such as grass clippings and leaves should be placed in a reusable container or in bags and tied. Clear or translucent bags are required.

SIDEWALK REPAIRS

Sidewalk Repairs are handled by the city's sidewalk rehabilitation program at no additional cost to residents. Through an annual sidewalk condition assessment, coupled with resident requests, sidewalks are identified and prioritized for repair or replacement based on the program's evaluation criteria. Repair work is done by city staff or a vendor. Report any sidewalks that are uneven or a trip hazard to 311 at 311@sugarlandtx.gov.



A QUICK REMINDER: If you see any issues at the neighborhood park that need to be addressed such as trash can needed to be emptied, removal of wasps nests, dog station bag refill or damages to the playground unit, please contact Sterling Management.

FIBER OPTIC INSTALLATION IN PROGRESS

Fiber Optic Cable is coming to Sugarland and our neighborhood. ATT, Ezee Fiber, and Tachus have been approved by the City of Sugar Land to lay fiberoptics in the community. All companies have been sending mailers and will be putting up door tags to notify you when they will be working in your area. AT& T is currently working in Glen Laurel at this time. Ezee Fiber and Tachus have not yet begun.

If the stations are low in bags or the trash can needs to be emptied out, please contact Sterling Management and we will notify our landscapers to take care of it right away.

CONCRETE FENCE UPDATE ON FLORENCE/MASON RD.

The Glen Laurel HOA Board of Directors has approved ABER Fence to replace the back wooden fence with the same concrete 6ft wall that has been installed along West Airport and Burney Road. The wood fence along the back of your house is on HOA property, by as much as a foot in some areas. The new wall will be placed away from the utility easements. The concrete fence on Florence Road should be completed by the end of May- weather permitting.

<u>Update on Mason Road Fence:</u> We are still working on the final details with the City of Sugar Land to obtain the funds for the approved FUN Grant. As soon as we received the green light from the City of Sugar Land, we will proceed with replacing the Mason Rd. fence in the next few months.

GLEN LAUREL HOA 2024 POOL SEASON

The Glen Laurel HOA Board has elected to change the pool registration and access system this year. Access to the pool will now be available to Glen Laurel residents who have registered and obtained a <u>2024 Glen Laurel Green Wristband</u>. Each household current with HOA dues and has completed the pool registration form will receive up to **6 green wristbands each year**, once the criteria noted above is verified. There will be a flat \$5.00 charge to obtain these wristbands. Each Glen Laurel resident and guest must have a green wristband to access the pool. Lost/replacement wristbands may be purchased for a flat \$20.00 charge at the management office.

Attached you will find the pool registration form, please provide the requested information and submit the pool registration form and payment prior to the pool registration date(s) below, the management company will have them ready for pick-up, all you have to do is show your ID to pick them up.

***Please note: the OLD GL plastic pool tags are now considered INVALID. ***

RENTERS: Renters will be required to show proof of residency, i.e. state issued id, utility bill, and their current lease agreement to obtain wristbands.
