MESSAGE FROM THE BOARD

With the upcoming Annual Meeting and Election of Directors, it is extremely important for each and every homeowner to be aware of what is going on in the neighborhood. There have been recent correspondences circulating in the neighborhood which have created confusion.

Bylaw Amendments

In 2011, the 82nd Texas Legislature passed many new laws regarding property owners associations. With regards to the Election of Directors, the legislation states that the position of any board member whose term has expired must be filled by an election by the members of the property owners' association not by appointment to the position by the board. A board member may be appointed by the board only to fill a vacancy caused by a resignation, death, or disability for an unexpired term. A board member appointed to fill a vacant position shall serve the unexpired term of the predecessor board member (Section 209.00593(a) of the Texas Property Code ["Code"]). So that our Bylaws are in compliance with the Texas legislation, the Glen Laurel By-laws were amended in March 2012 as provided by Section 209.00593(b) of the Code, which states "The board of a property owners' association may amend the bylaws of the property owners' association to provide for elections to be held as required by Subsection (a)." In essence, this Bylaw amendment establishes a process for electing directors by a mail balloting process, in the event a quorum cannot be established at the annual meeting (as has been the case since 2008) – all in compliance with the said Section 209.00593 of the Code.

The current proposed amend to Section 7.06 (to be voted on at the 2012 Annual Meeting) makes it clear that all three of the positions of the current board members are up for election at the 2012 Annual Meeting (due to Section 209.00593 of the Code), but to keep the positions staggered the amendment provides that one position will be for a one year term, one position for two year term and one position for a three year term. This amendment is more "housekeeping" than a substantive amendment.

The best way for members of the community to know what is going on in the neighborhood is to attend the monthly meetings, which are held on the second Tuesday of each month, to get a first-hand account and not a second-hand narrative.

Moving forward, as stated in our last newsletter, there are several issues that we are working diligently to resolve.

Annual Assessment/Amendment to Declaration

Article IV, Section 1

For the past **seven plus** years, we have paid in annual assessments of \$425 per lot per year. At this point, \$425 per lot per year is the maximum amount that can be assessed regardless of the rising cost to maintain the neighborhood. These costs include landscaping and lawn maintenance of the common areas, the pool operations and maintenance, lake maintenance, fountain maintenance, the cost for utilities, irrigation,

Unfortunately these

administration fees, legal fees, collection fees, and more. Unfortunately, these costs have not been stagnant like our dues. Imagine, if you have not received a raise from your job for seven years, would you be able to afford your standard of living with the ways costs have risen?

If passed, the proposed amendment to the Declaration of Covenants, Conditions and Restrictions for Glen Laurel will reset the dues to \$475 per lot per annum for 2013 with allowed increases of up to 10% over the previous year's annual assessment. However, please note that this **does not** mean that there will be an automatic 10% increase every year. The amendment only allows for annual increases for up to a *maximum* of 10% to meet community needs, if required. Any increases greater than 10% per year will require a majority approval from 2/3 of the Members of the Association that vote in person or by proxy, absentee ballot, or electronic ballot in an annual meeting or special meeting called for the purpose of increasing the annual assessment by more than 10%.

Article IV, Section 4

In addition to the removal of the Annual Assessment cap and moderate allowed increases, the proposed amendment to the Declaration will fix the quorum requirement for meetings called for the purpose of increasing the annual assessment by more than the maximum annual rate of increase allowed under the Declaration (i.e., if approved, 10%), and (iii) to levy a Special Assessment for capital improvements.

The purpose of amending the quorum requirement is to provide an equitable solution that will enable the Association to conduct business and provide all lot owners the opportunity to vote on any actions at a meeting called for the purposes outlined above. If this amendment is approved by a majority vote of the Glen Laurel owners, the quorum requirement for a meeting called for the above specified purposes will be amended from 60% of Membership to 20% of Membership. Since 2008, the Association has not had a quorum at an Annual Meeting. The quorum requirement to conduct business at an Annual Meeting is 10% of Membership, or 72 lots. The proposed amendment provides for a much more realistic quorum requirement for a meeting called for the above specified purpose; yet, it remains more stringent than that required for an Annual Meeting.

Aging Assets

Over the past several years improvements have been made to the community's amenities. Investments have been made at the pool area including a renovation of the pool itself; additional deck area; added shade covers; a new and working slide along with the replacement of the aging, broken and missing pool furniture; and additional parking.

Sugar Land Middle School Lanyards

In order to keep parents informed the school began a pilot program for student ID badges. The week of 10/17 during 7th period class, all students received a complimentary ID badge and a Sugar Land Middle School Lanyard for their ID badge. All students must wear their ID badge while at school or school related events. The use of the ID badge was implemented for safety reasons for the arrival and dismissal of students on campus, access to issuing textbooks accurately, membership to clubs, checking out library books and to designate grade levels among the student population. If your child loses his/her ID badge a replacement ID badge will be given to your child free of charge through the front office staff. 25TH ANNIVERSARY OF BLACK MONDAY 10/22/2012

October 19, 2012 was the 25th anniversary of BLACK MONDAY. Monday, Oct. 19, 1987 was a unforgettable day and a major landmark in the history of the stock market. I was a young rookie Financial advisor, but the memories from that day will never be erased. The Dow Jones Industrial Average (DJIA) dropped from a value of 2247 to 1739. This was a loss of 508 points (23%). In



the present situation, this would be equivalent to a 3,000 point drop in the DJIA. There was total chaos and panic on Wall Street. So, this day is called BLACK MONDAY. Most mutual funds in the category of growth funds also suffered a proportionate loss of value. Growth fund account values of some of my clients dropped from \$100,000 to \$77,000 in one day. It took 1 year and 3 months for the DJIA to recover the loss. Friday, Oct. 19, 2012 was not a good day on Wall Street. DJIA lost 205 points and closed at 13,343. However, 25 years after Black Monday, the DJIA has grown by 6,673% (6.67 times).

Now let's take a trip down memory lane. In the 25 years since Black Monday, the DJIA soared through the 1990s and reached 11,722 on Jan. 14, 2000. This was followed by the bursting of the dot com bubble, terrorist attacks on the World Trade Center, collapse of ENRON and a few corporate scandals. On Oct.9, 2002 the DJIA had dropped to 7286 (loss of 38% since 1-14-00). This was followed by a bull market which lasted exactly 5 years. On Oct. 9, 2007, the new all- time high for the DJIA was 14,164 (gain of 94%). Then came the collapse of the housing market and one of the worst financial crisis in US history. On Mar.9, 2009 the DJIA closed at 6,547 (loss of 54% since 10-9-07). Oct.9, 2012 was the 5th anniversary of the highest level of DJIA. During this 5 year period DJIA has lost 4.88%. But during the 10 year period ending 10-9-12, the DJIA has gained 85%. Are you feeling dizzy! This is the market roller coaster!

Through all this market volatility, Growth funds or stock funds have experienced wild fluctuation in account values. Several Bond funds and Fixed annuities have performed well in the last 5 to 10 years. Dividend distributions from Corporate bond funds and Govt. Securities funds are taxable but those from Municipal bond funds are exempt from federal income tax. None of these bond funds offer safety of principal or guarantee of future returns, however during the most volatile stock market conditions the fluctuation in their share price is minimal. Interest earned on Fixed annuities is tax deferred until partial withdrawals are taken or the annuity is fully surrendered.
