MESSAGE FROM THE BOARD

Glen Laurel awarded \$45,000 from the City of Sugar Land

During the March meeting of the Sugar Land 4B Corporation, Glen Laurel was awarded approximately \$45.000.00 from the City of Sugar Land to help pay for the construction of the concrete wall on Burney Road.

This is the second time in as many years that Glen Laurel has received money from the Sugar Land 4B Corporation for the construction of perimeter fences. Prior to sending in our application, the HOA was told that there was little chance we would be given money two years in a row. But the 4B Corporation was so impressed with the wall on West Airport, they took the unprecedented step of assisting the HOA again.



Reason for delay in starting fence construction

4B Corporation rules would not allow us to start the last part of the wall construction until the contract between the City and Glen Laurel was signed. Unfortunately, it took longer than expected for the 4B Corporation to award the money to the HOA, and the fence construction went faster than estimated. That is why there was a delay of several weeks between the construction of the main part of the wall and the start of the wall between Silvermill and Florence. Hopefully, by the time this newsletter reaches you, the wall will be completed.

Mason Road fence replacement to begin

After the completion of the wall on Burney Road, the HOA will then turn our attention to the wood fence along Mason Road. Letters will be mailed to homeowners whose fences back up to Mason Road advising them of the approximate start date.



SUMMER SAFETY FOR CHILDREN

- You all know how important sunscreen is, but did you know that it expires? A good rule of thumb is to use the sunscreen in the same season that you bought it, then toss it.
- Swallowing a lot of pool water can cause electrolytes imbalance by altering the salt to water ratio. This can lead to vomiting, lethargy, and, in extreme cases, seizures.
- Bee sting? Make a paste of meat tenderizer (the nonflavored kind) and water and rub it on the sting. It will help break down the toxins quickly.
- A popsicle makes a great ice pack for "owies" in or on the mouth.

Summer fun can bring accidents. No matter how careful we are with our children, accidents will happen. When one happens, taking care of it quickly is vital. Having a First Aid kit handy can relieve the pain and worry for both the parent and the child. You can either purchase a kit and add things or make your own. Here are a list of items recommended to have on hand:

- Tote bag or small box/ one for the car & one for the house.
- First aid manual, read it before you need it.
- Syrup of Ipecac (check the expiration date) to counteract certain poisons
- Disposable, instantactivating ice bags, used to minimize swelling
- Small scissors
- Tweezers
- Gauze pads
- Adhesive tape
- Adhesive bandages, various sizes
- Hydrocortisone cream
- Antiseptic cream

POOL TAG INFORMATION:

The following requirements must be met in order to receive Pool Tags and use the pool facilities:

- 1.Must be property owner and resident member of Glen Laurel HOA.
- 2. Must have paid <u>current annual maintenance fees</u> in order to receive pool tags.
 - a. <u>If renting</u>, you will not receive Pool Tags if the property owner is not up-to-date with maintenance fees.
 - b. Maintenance fees WILL NOT be accepted at the pool site. Please contact Sterling Association Services to pay.
- 3. Must show swim tag and sign in with lifeguard <u>each time</u> you arrive at pool.
- 4. May bring up to two guests per family
- 5. Children 12 years of age and under must be accompanied by an adult 18 years of age or older.
 - a. Anyone not following lifeguards' instructions or acting in a disruptive manner may be asked to leave the pool facility.
- 6. Pool tags are for <u>residents use only</u> and may not be given to or shared with non-residents. Doing so may result in loss of pool privileges.

Be A Good Neighbor: Six Good Reasons To Leash Your Dog

Virtually every community has a leash law. The law requires that dogs be kept on a leash at all times when on public property. While on private property, dogs must be under the control of their owners. The intent of this law is to protect the health and safety of the public and to protect your pet. The use of a leash will benefit you, your neighborhood, and your pet. There are many good reasons to keep your dog on a leash.



- 1. It's a great good neighbor policy, preventing your dog from trespassing on neighbor's property during your walk. It also keeps your dog from jumping on people you encounter, ensuring that your dog has the chance of being properly introduced.
- 2. Improved companionship. A well trained and leash-obedient dog is a pleasure to walk with.
- 3. Walking your pet on a leash will prevent the spread of disease. It is less likely that your dog will be exposed to Parvo or Distemper. A leashed dog can be restrained from sniffing the droppings of other animals.
- 4. A leash is commonly referred to as "Your Pet's Lifeline," protecting your pet from traffic and unrestrained animals. Accidents or animal bites are greatly reduced when responsible pet owners obey the leash law.
- 5. An obedient and well behaved dog is a positive reflection of its owner.
- 6. Re-locating your dog into another household is 100% easier if your dog is obedient and leash trained.

Be a good neighbor. Be a good friend. Use a leash.
