To Register for the 2025 WFE Spring Fling:

1. Please read all the attached Rules of Participation and Complete the Contract and Sign

2. Enclose payment/check and a complete schedule of shows for the upcoming year. Booth spaces are only reserved once a signed contract and deposit are received and are First Come First Served.

The WFE 2025 Spring Fling Contract

1. I understand that all payments made hereunder are not refundable.

2. I understand that this is a legally binding contract.

3. By signing this contract, I acknowledge that I have read and agree to the following:

a. Photography and Model Release: If my booth is chosen to be photographed or videoed during the course of the show by WFE and I agree to grant WFE the right to photograph or video my booth, product, booth workers or customers, I agree to have these pictures, portraits, and likeness to be used in an unrestricted territory, for unlimited use, to be kept for an indefinite time period, as file photographs or videos with no compensation. These photographs/videos will be owned by WFE and will be used for future promotional print or video advertising of the shows including, but not limited to press releases, brochures, or other printed materials, print and television advertising. WFE will cooperate in a timely manner to photograph booths.

b. Music Copyright Infringement: If I intend to play copyrighted music at my booth, I agree to provide WFE thirty days' notice prior to the commencement of the show, a copy of my company's license to perform or play copyrighted music at my booth. This applies to both recorded and live music and is following federal copyright law.

c. Inventory to be Sold: I agree to sell at WFE only the inventory which has been juried and approved by WFE. I have submitted a complete list of these products with this contract. I understand that I cannot sell any inventory at WFE that has not been juried by the WFE and that failure to comply with this policy can result in my immediate expulsion from the show and I will forfeit all booth rental fees paid to WFE and my future participation in WFE shows. I further understand that during the show all inventory, business sales and promotions including tapes and CD music being played either for sale or for atmosphere must be contained within the confines of the rented booth space and must not invade either the audible or physical space of surrounding booths.

d. Sales Tax: All exhibitors will be required to charge the NC sales tax of 6.75% on all sales and orders.

e. Liability/Insurance: Neither Crown Complex nor its agents or employees, nor the WFE shall be liable for any damage to the property of or for the loss of any business to the exhibitor, or for any loss of the exhibitor by theft, or damage by fire or other means, or for any injuries to the exhibitor, its employees, agents, customers or guests arising from any cause or matter whatsoever.

f. Fire Marshall Rules: All exhibitors must adhere to the NC fire code regulations and specifications and can only use non-flammable booth decorations. If booth decorations are deemed flammable, if booth decorations are deemed flammable, they must be treated with flame retardant solutions. All electric wiring must conform to the National Electrical Code.

g. No microphones. No loud noise. No selling in the aisles.
