Pre-Orders & Lead Times

Due to our traditional 100% natural sourdough fermentation process, sufficient lead times are required for production planning.

- Bread Orders: Minimum 2 working days notice by 3 PM
- Pastry Orders: Minimum 3 working days notice by 3 PM

Last-minute orders are subject to availability and cannot be guaranteed.

Order Structure

Delivery Policy

- Minimum order value for any delivery: R500 net
