TERMS & CONDITIONS

These Terms and Conditions ("Agreement") are entered into by and between EPOCH PRIDE PAYROLL AND CONSULTING FIRM ("Epoch Pride") and the client ("Client"). By engaging Epoch Pride's services, the Client agrees to be bound by the terms and conditions outlined below:

- 1. **SERVICES:** Epoch Pride agrees to provide payroll and consulting services as mutually agreed upon by both parties. The specific details of the services, including but not limited to payroll processing, tax compliance, and consulting, will be outlined in a separate agreement.

- 6. **GOVERNING LAW:** This Agreement shall be governed by and construed in accordance with the laws of the jurisdiction specified in the separate agreement.
- 7. **LIMITATION OF LIABILITY:** Epoch Pride shall not be liable for any indirect, incidental, consequential, or punitive damages arising out of or related to this Agreement. Epoch Pride's total liability for any claim shall not exceed the total fees paid by the Client under this Agreement.
- 8. **FORCE MAJEURE:** Epoch Pride shall not be liable for any failure or delay in the performance of its obligations under this Agreement due to circumstances beyond its reasonable control, including but not limited to acts of God, war, terrorism, labor disputes, or natural disasters.
- 9. AMENDMENTS: This Agreement may be amended only in writing and signed by both parties.
- 10. **ENTIRE AGREEMENT:** This Agreement, along with any separate agreements referenced herein, constitutes the entire understanding between Epoch Pride and the Client and supersedes all prior agreements, whether oral or written.
