**Oil Painting Competition (Nov 2022-January 31, 2023)**

Following rules and regulations will be strictly implemented. Entries may be disqualified for technical reasons. Your participation in the contest affirms your agreement to these Rules:

1. Contest is open to all Filipino artists, and those of Filipino descent, from age 15 and above, professionals, students and out of school youth are all welcome to join this OPEN CALL;
2. Theme of artwork must be religious, including Catholic Devotion (Marian, Holy Angels and Saints) over the last 500 Years, style must be figurative and representational, no abstract.
3. **Medium:** oil on stretched canvas, gallery wrapped, thickness: 1"-1.5" (paint the side black)
4. **Size:** 30" x 40" horizontal or vertical, unframed and unsigned, artist's name at the back;
5. Works must be current dated 2022, started not earlier than 2021, must be an original work not exhibited or awarded prize in any other contest;
6. There is no participation fee, but Eagle Eye Charities Inc (EEC) reserves the right to sell the entries during actual and online exhibitions through its website <https://EagleCharities.org> at a price agreed upon with the artists: **60%** paid direct to the artists, and an equivalent **40%** donated to EEC nonprofit organization for humanitarian causes and for Catholic outreach.
7. **Deadline of submission of high-resolution digital image is January 31, 2023**, please email your entries to: [galleryeec@gmail.com](mailto:galleryeec@gmail.com) **Finalists will be announced on February 5, 2023**, prepare to deliver your unframed works, **for exhibition on February 14-28, 2023 in Manila.**

9. Participants are responsible for cost of transportation to and from point of origin;
10. **Final winners will be announced during the opening of the Exhibition on February 15, 2023**, Judges' decision is final. Prizes will be donated by EEC sponsors, as follows:

15. Top Three winners and Juror's Choice (9) winners will be invited to an interactive mural size 6' x 8' or larger, during the February 2023 Art Exhibition, subject to space limitation, and will be donated to MANA in commemoration of this event.
