CHECK-IN & CHECK-OUT PROCEDURES

IT IS REQUIRED THAT YOU SIGN IN AND SIGN OUT YOUR CHILD EACH DAY. IF ANOTHER ADULT OTHER THAN A PARENT OR LEGAL GUARDIAN IS PICKING UP, WE REQUIRE THAT THEY MUST BE AN AUTHORIZED PERSON LISTED ON THE CHILD'S REGISTRATION FORM. ANY PERSONS NOT LISTED ON THE FORM (I.E. VISITING RELATIVE, FRIEND, ETC) MUST BE COMMUNICATED IN WRITING BY THE PARENT OR LEGAL GUARDIAN WITH ADVANCE NOTICE. ANYONE PICKING UP YOUR CHILD MUST PRESENT A VALID ID.

PAYMENT POLICIES/TERMS
