Board Minutes**

**Call to Order:** The meeting was called to order by President Hudson at 10:04 a.m.

**Invocation and Pledge of Allegiance:** Mayor Hudson led the pledge, and the invocation was led by Vice Mayor Jolien Caraballo.

**Self-Introduction of Board Members, Alternate Members and Guests** President Hudson asked for a self-introduction of members and guests.

**Approval of the Agenda:** Councilman Carroll made the motion to approve the agenda, seconded by Mayor Ostrand. Motion passed unanimously.

- Fort Pierce – Mayor Hudson said the city had a number of issues they are wrestling with, including a City Manager search.
- Ocean Breeze – Mayor Ostrand reported a resolution between the town and Sn Communities was approved.
- Sewalls Point – Commissioner Mayfield asked about other cities approving revenue to pay for projects that aren't necessarily the city's responsibility. There was a discussion with other cities.
- Stuart -Mayor Rich announced Costco was opening in April.

- Port St. Lucie - Vice Mayor Caraballo reported the first Police Department class graduated from the Police Academy the city started to help fill the vacancies in the department. The City is also constructing a PD Training facility onsite.
- Fellsmere- Councilwoman Macias reported the Annual Frog Leg Festival was coming next weekend.

## **Old Business**

- New Elected Officials Workshop – Mayor** Hudson reported that the second workshop, held in November, was a success. There were ten City elects and three County Commissioner elects. There will be some discussion for future classes and a decision on whether County elects will be part of the class.
- Delegation Meeting Updates** – Presentations were made in St. Lucie, Indian River and Martin Counties for the delegation meetings. No one was available for Okeechobee.
- Advocacy Team Update-** Mayor Ostrand announced an Advocacy Team Meeting will be held on Thursday afternoon via Zoom. A discussion on the trip to Tallahassee will take place and who will attend. There are several new members.
