Call to Order: The meeting was called to order by President Ed Dodd at 10:06 a.m.

Invocation and Pledge of Allegiance: Councilman Dodd led the pledge and Mayor Joel Tyson led the invocation.

Self-Introduction of Board Members, Alternate Members and Guests President Dodd asked for a self-introduction of members and guests.

Additions and deletions to the agenda: None

Approval of the Agenda: Mayor Linda Hudson made the motion to approve the agenda, seconded by Mayor Joel Tyson. Motion passed unanimously.

Motion to Approve the Consent Agenda was made by Mayor Linda Hudson, seconded by Commissioner Campbell Rich. Motion passed unanimously.

President's Report: President Dodd updated the membership on the upcoming FLC Conference in August, encouraged everyone to attend. He also reported that many cities are reviewing the new legislation on Affordable Housing to determine the bill's impact on their cities. He also reported on the FLC Board meeting and how the League who owns property in Orlando will be selling a piece and using the funds to update and renovate the existing building.

City Reports

- Okeechobee City Manger invited everyone to visit Okeechobee and view the new bronze Cattle Sculptures on Park St.
- Vero Beach Councilman John Carroll reported on the challenges of moving the treatment plant off of the property on the Indian River. The City of Vero won appeal against Indian River County

- Mayor Hudson reported the city is working on dealing with outdoor music. People are complaining. There is also a lot of roadwork in progress as FPUA is moving utility lines.
- Councilman Ed Dodd mentioned the City of Sebastion is discussing the Police Department future. The City Attorney resigned and went to Melbourne. The City Manager also retired.
- Mayor Joel Tyson reported on the three new housing developments. One will include a Publix or Winn Dixie with 375 workforce units. The City is holding a workshop for businesses along Broadway, to see about redeveloping the area.
- Mayor Bill Theiss reported the town is pushing to get utilities to the residents using ARPA funds to design the project. Goal is to design the north.

Legislative Matters – Discussion on Form Six. The Commission on Ethics will oversee. There will be a program on the topic at the FLC conference in August. More information to follow.

New Business:

- a. Policy Committee Signup President Dodd and Past President Caraballo encouraged the members to sign up for the upcoming Policy Committees for the 2024 Legislative Session. Our goal is to have at least one member on each of the five committees. It is OK for more than one member to sit on any committee, but the goal is to have at least one. After a discussion, they agreed to apply to sit on the following committees.

 - Utilities, Natural Resources and Public Works Commissioner Campbell Rich
- b. Final Report on Scholarship Recipients: The final Scholarship recipients were recommended to the membership. Their applications were included in the backup for review by the members. The two are Luke Capezza who is recommended for the TCRLC Vocational/Technical/Agricultural Scholarship and Angelyssa Linton is recommended for the TCRLC Public Administration Scholarship. Each will receive a one-year scholarship to IRSC if approved. Mayor Linda Hudson moved approval of the recommendation and the motion was seconded by Mayor Karen Ostrand. Motion passed unanimously. The Scholarship presentation will take place at lunch.
- c. Nomination for the District 9 Representative for the Florida League of Cities Board Executive Director Christensen explained that no final decision was made during the Strategic Planning session on how the Associate Members could be made to feel a bigger part of the TCRLC.
