

**Treasure Coast Regional League of Cities
Minutes – October 15, 2025

Board and Lunch Meeting**

Call to Order: The meeting was called to order by President, Mayor Linda Hudson at 11:10 a.m.

Invocation and Pledge of Allegiance: President Hudson led the pledge.

Self-Introduction of Board Members, Alternate Members and Guests President Hudson asked for a self-introduction of members and guests.

Approval of the Agenda: Councilman Bob Auwaerter made a motion to approve the agenda, and Councilman John Carroll seconded the motion. Motion passed unanimously.

Consent Agenda:

- a. Approval of the Minutes for March 2025
- b. Approval of Treasurer's Report for March and April 2025

Motion to approve the consent agenda was made by Councilman John Carroll, seconded by Councilman Bob Auwaerter. Consent Agenda passed unanimously.

President's Report: Mayor Hudson spoke about the pending Bills the House proposed for Tax Amendments to go on the ballot. There was a brief discussion on a few of the proposals.

Old Business

- a. **Housing Accelerator Task Force Update** – in the absence of Vice Mayor Caraballo, Executive Director Christensen reported to the Board on the decision by the committee to delay further action by the committee until legislative session is over since everyone will be dealing with the bills and tax proposals that will be top of mind for the next few months.

A motion was made to accept the recommendation to put a hold on the committee until after session was made by Councilman John Carroll, seconded by Alderwoman Ingrid Van Hekken. Motion passed unanimously.
