Each animal submitted must meet the registration requirements as stated in the ATSA breed up guidelines. Registrations for rams must be accompanied by proof of RR or QR at codon 171. Codon 171 testing results for ewes is optional, except as follows: All offspring of QR rams (both ewe lambs and ram lambs) must test RR or QR to be accepted for registration. NOTE - if we have RR codon test results on file for the sire and dam of any lamb, we will waive the testing for the lamb - as it is a given that the offspring must be RR.

Fee for each animal less than 12 months of age - \$ 10.00 Fee for each animal from 12 to 24 months - \$ 20.00

Animals over 24 months old are NOT eligible for registration

Registration AND Transfers submitted at the same time need to add an additional \$10 per transferred animal and include a Transfer Form.
