### Important information to note

### Background

All submissions made **must relate to the aspects of the EPBC Act that are assessed**. Only Matters of National Environmental Significance (MNES) are of interest. In the case of Woogaroo Forest, this includes **KOALAS, Grey-Headed Flying Foxes, Swift Parrots (seen seasonally in the area), Regent Honeyeaters (seen seasonally in the area), Migrants such as Rufous Fantail, Black-faced Monarch, Spectacled Monarch, and White-throated Needletail.**

If you know anything else that the EPBC might find to be of interest, then please make sure to include it.

- **If you made any submissions up to COB Friday 12 December you MUST re-submit your email, as they have all been lost. Please copy the recommended emails in your submission.**
