



#### A LITTLE HISTORY

I joined the LSBTC in 1984 after acquiring my first Terv Penny in December of 1983, and my collection of newsletters starts with April 1984--Volume 2, Issue 1. I don't have the first year of club newsletters, and if anyone out there has them, I'd love to see them!

The 1984 masthead for the newsletter:



As I understand it, the logo had been designed by Miki Castro (now Baiocchi). The name "TEXAS TERV TRAILS" started with the next issue, from a newsletter naming contest.

A new logo, designed by Bev Ryba, also arrived with that issue, and lasted for many years:



Many of the early articles were written by Miki. She chronicles some of the club's issues that (alas!) we can still relate!

VOLUME 2 ISSUE 1

April 1984

The February meeting of the LSBTC was held 2-19-84 at the Victoria show. It was decided that the next regional supported show would be held in the Dallas area with Sallyann Comstock as chairperson. (Ed. note: at the time we were referring to the 1985 supported, but that has since been changed. The 1985 supported will be held in Oklahoma with Ruth Harris as chairperson, Sallyann will do the 1986 supported. See details elsewhere.) Regarding the 1984 supported show in San Antonio, the membership voted to request chairperson Elly Clarke to arrange for rosettes to be awarded for the following places: BOB, BOS, BW, WD, WB, and HS Terv in Trial. Jeannie Valdez was requested to contact San Jacinto KC regarding our trophies which were left over from the last show. A Herding Test committee was established withh Sallyann Comstock and Miki Castro as co-chairpersons. Due to the fact no one from the nominating committee was present at this meeting, and no nominations had been received by the committee, the membership voted to make nominations from the floor at this meeting and hold nominations open through the next meeting so as to accommodate any other nominations from the nominating committee or any other members. The newinations were as follows: President Callyann Comstock, Vice President Miki Castro, Sec/Treasurer-Jeannie Valdez, Directors-Monika Brown and Snady Bennie. L.T. Bowman moved to adjourn, Sandy Bennie seconded.

The March meeting of the LSBTC was held 3-11-84 at the San Antonio KC show. There was discussion concerning the trophies from our last supported show which were retained by the San Jacinto KC. According to their spokesperson, the trophies have been "disposed of". Because of this experience, future supported show chairpersons are warned to arrange in advance as to the disposition of any left-over trophies. Our first choice would be that the trophies be returned to the LSBTC. If that is not acceptable to the show-giving club then we will request that the trophies will be offered for our breed in the name of the LSBTC at their next show. Since at this time our club does not have a constitution, Sandy Bennie will mail a proposed constitution to the membership at least 10 days before voting at the Beaumont meeting. Miki Castro provided a copy of the constitution of the Great Lakes Belgian Tervuren Club for consideration. At this meeting the membership voted to seperate the offices of secretary and treasurer and to create a third position on the Board of Directors. Additional nominations to fill these places were as follows: Secretary-Laurie Ashelin, Director-L.T.Bowman. The nomination of Jeannie Valdez to the position of secretary/ treasurer from the previous meeting was amended to a nomination for treasurer. Sallyann Comstock reported that the Dallas area clubs are planning a "Super Show Series" for 1986 which will include specialties the day before the all-breed shows. The Dallas people are intent on making these shows the biggest shows of 1986, and are going all-out to create a real extravaganza. Local specialty clubs are being asked to pick their judges. Sallyann

Sadly, there was also news that for those of us that lived through the early parvo days reflects the fear we felt.

Our Brittany bitch, Cookie, had a perfectly normal stool on Saturday evening, and severe diarrhea on Sunday afternoon. She was worse on Monday morning, in spite of having received several doses of medication. She was taken to the show veterinarian on Monday, and came home with an IV needle in her leg. My veterinarian diagnosed a Corona-type virus, and treated her with fluids, Kaopectate, and Hill's ID (Intestinal Diet). Cookie had improved dramatically after just half a bag of fluids, but it took a full week for her stool to return to normal. She was lucky - a Greyhound which was also taken ill at the show was in shock at the time we took Cookie in to the show vet. My
