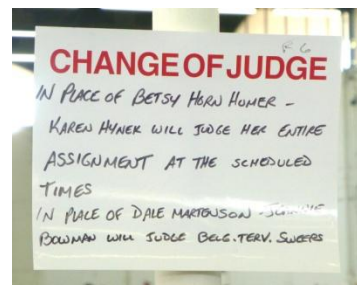

In the absence of a Secretary, Sarah said that there were no additional nominations for Board members.

Report of the Treasurer

Jeff reviewed the Treasurer's report, since Shirley did not attend. He also mentioned that the Supported Show expenses were small thanks to Deb's not charging for the trophies and Cynthia providing exhibitors' gifts from the ABTC General Store. Cynthia also mentioned that she had asked that ABTC give local clubs cut rates from the ABTC store, but had not heard back from them. Jeff said that the biggest expense was the rosettes offered.

Election of New Members

Karen and George Weems submitted an application for a family membership and were voted into the club.

Unfinished Business – Facebook Administration

New Business - LSBTC Website

New Business – LSSC December Shows Moving to February

Cynthia brought up that the Lone Star State Cluster will be moving its December show to February. The July show will remain as currently scheduled, and both will be held at Market Hall in Dallas. The 2024 dates are February 8-11, 2024.

Since there is usually a club meeting at the December show, we will probably move the meeting to February.

New Business – 2024 Supported Show

There was a brief discussion of having a 2024 Supported Show, but it will be continued at the next meeting.

Cynthia did mention that she had been asked about voting for judges, but that for a supported show we have to choose from among the judges selected by the show-giving club or bring in another judge at our expense.

She did suggest that for a supported show we contact the show-giving club for a list of the judges that are approved to judge Tervs to see if there is someone that would be good to judge our Sweeps.

There was discussion of holding one at either Houston or Fort Worth, but both sites are very expensive for exhibitors when parking is taken into account.

The next meeting will be held at the Travis County Kennel Club show at the Bell County Exposition Center in Belton, TX after breed judging on Saturday, October 28, 2023.
