LONE STAR SPOTLIGHT

MULTI GROUP PLACING, BOSS CH SKY ACRES AMERICAN CLIPPER, MX MXJ HC

When Susan asked me to write something about Clipper, I immediately thought back to when I flew out to Oregon and picked her up. Michelle had picked out two girls for me to look at. We watched their movement on a video she had made at 6 weeks and then I went out to the puppy pen. With all the puppies playing I threw a toy to the first girl she had picked out. That girl took the toy and went over to the corner to chew it up.

I got another toy and threw it near the other puppy. She went after it along with all the puppies. She was pushed away from the toy but dove back in and came up with it and brought it back to me....I said "I want this one". I had been there less than 5 minutes. I have never regretted that decision.

Clipper is my thoughtful and decisive Terv. She has never been shy about doing anything. Whether she is working in agility, heeling and jumping next to me in Rally or leaping while in the Conformation ring, she always does it with a clear goal in mind....get the food and keep everyone happy.

Clipper finished her Championship easily and has earned over 80 Best of Breeds, 10 Group Placements, an Award of Merit at the National Specialty, two Best of Opposite and two Best Puppy in Sweeps at our Regional Specialty. She has her MX & MXJ in agility working toward her MACH and we are over 3/4 of the way there with both Jeff and I running her. She has earned her Herding Certificate and she is getting ready to be shown in Rally. No matter what I ask her to do, she is ever so willing to give it a try.

Trophies will be soft-sided coolers of varying sizes, with Deb Lyons to work with Cathy (of T-shirt fame) on the logo. We will again offer the banquet at a reduced rate to encourage attendance (Sarah moved & Pat seconded charging \$25.00 for the banquet, with the additional being paid by the Club. Motion passed).

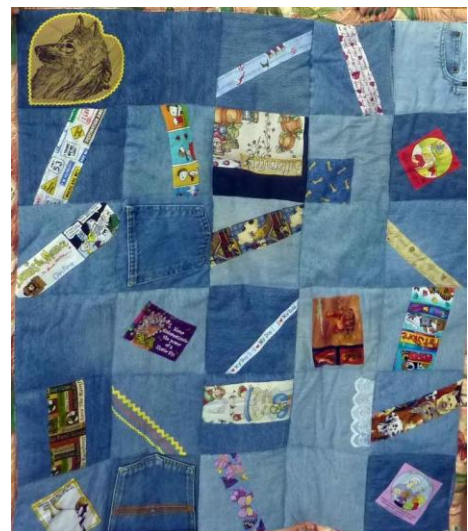

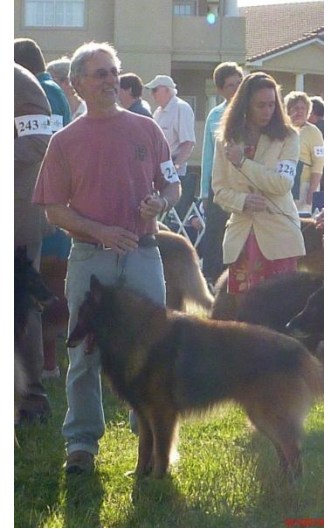
