



Dear Salt Cove Wellness Guests,
we have been diligently working behind the scene making sure we are ready for reopening time. We are very excited with the changes and safety measures we have implemented.

Important Notice For Salt Cove Wellness Guests & General Public:

Due to the recent coronavirus (COVID-19) pandemic outbreak and the absolute need to take appropriate measures to protect ourselves, our loved ones, our neighbors, and any encounters, **Salt Cove Wellness** will like to assure our guests that we are taking every cautionary step to keep everyone safe while visiting our facility. We are using all available protective and safety measures.

New Safety Guidelines to Follow Upon Reopening of Our Facility:

Upon arrival to Salt Cove Wellness every guest will proceed to wash their hands. The guests will be asked about their physical status in regards of any symptoms and well-being that may indicate a respiratory infection. In the event that the guest is feeling symptomatic the guest is expected to reschedule the appointment. If there is any likelihood that you have active symptoms, you will **NOT BE PERMITTED** to attend your session.

We are doing things differently. Our salt therapy sessions have always been private, now we have decreased our salt room capacity and our classes & group events are kept small. Below is a list of our changes:

- Upon arrival guests will be prompted to immediately wash their hands.
- We have placed hand sanitizers throughout the facility.
- We are cleaning the facility with increased frequency between each guests.
- The faucet has been converted to touch-less water dispenser.
- The soap dispenser is motion sensor decreasing risk of infections.
- After every session the exhaust vent time will be extended to 30 minutes instead of 15.
- We have a floor stand UV light that is used throughout the facility.
- Besides the salt room's own ventilation system, there is a separate facility exhaust that is use post UV light.
- To allow enough time to clean and disinfect the facility, the time between appointments has increased to be 30 minutes instead of 15.

Salt Cove Wellness Distance Protocol:

Mask must be worn for conversations within 6 feet or closer. When keeping 6 feet social distance, wearing the mask will be your choice. No mask should be worn in the salt room while session is in progress. For Vibrational Sound sessions I will be wearing a mask. To keep social distance guidelines the salt room capacity has been decreased to 3 chairs.
