- As most of you know, we lost an active Sister in Blue, Keona Holley, after she was shot in the head by two dirt bags. The BRPBA Board was polled, and we made a nice donation to this family. We hope this helped them during this time of struggle.
- I have received many phone calls and emails regarding the lawsuit, to the point where I am frustrated by the confusion, so let me try to explain a few things. The lawsuit was begun with

the hopes of helping those Brothers and Sisters in Blue who were victims of the City Government. If it wasn't for the lawsuit, they would have received nothing.

Certain people who retired in a certain timeframe were deprived of a raise that everyone else had gotten. As a result, the unions felt this was unfair and decided that we were going to join together, fire and police, active and retired, and sue the City over this pension issue. At the onset of this, the City Government was so arrogant and ignorant, they thought they were going to win. As the lawsuit progressed, in Federal court where we began the lawsuit process, Judge Garvis ruled against the City and he referred everything back to State Court. This was not the lawyers doing this, this was the judges decision. Judge Julie Rubin received the case and after a lengthy trial and hearing from the Union side and the City side, Judge Rubin ruled in our favor. The only thing she did, that we were against, was she accepted the City's actuary numbers instead of our own. Our figures were higher. When the dust finally settled, we prevailed and then it went to the Court of Special Appeals and they said that we had won and the City had to pay us, and magically, the City found the money for the folks that were aggrieved and lost out on income. The people who complained were wondering why they didn't get a penny, but most of these people were retired prior to the City changing the rules and received all of their raises.

MAN FOR ALL SEASONS

This article is coming to you a bit late, but we did not receive the information in time to place it in our last newsletter.

On October 28, 2021, our Board member, Mike May, was honored by St. Thomas More Society of Maryland at their annual "Man for All Seasons" Award Banquet.

For those of you who do not know, Mike is a retired Military Police Sargeant who served with the 4th Infantry Division of the U.S. Army. Upon his return to civilian life, Mike joined the Baltimore City Police Department where he rose to the rank of Detective Sargeant. In 1975, Mike chased a fleeing felon out a window, whereby shattering his right ankle and left foot when he landed on the ground. These injuries ended his career as a police officer. While working at the BPD, Mike attended Loyola University where he graduated with a B.A. in Sociology in 1973 and then moved on to the University of Baltimore where he obtained his Master's Degree in Criminal Justice in 1976. He then enrolled in law school at the University of Baltimore, where he served as the Managing Editor of the Law Review and graduated second in his class in 1980.

After law school he joined the Baltimore law firm of O'Doherty, Gallagher and Nead, where he later rose to be named a partner in the firm. In 1997, he formed the Offices of Michel P. May, where he still practices today.

In addition to his law practice, Mike serves as a Judge Advocate of the National Fourth Infantry Division Association and as Secretary of its Carolina Chapters. He also serves on the Military and Veterans Affairs Committee of the Maryland State Bar Association, and as a member of the Baltimore City Veterans Service Court.

Mike joined the BRPBA in 2002 and became a member of the Board in 2011. He currently holds one of the Board of Governors positions.

That Mike was honored with the "Man for All Seasons" award by the St. Thomas More Society of Maryland is no surprise to the BRPBA. Mike is always there when asked. He is a proficient writer of many of our newsletter articles, is called upon for legal advice consistently, and despite all he has been through, is a kind and considerate man.

COVID-19 AND 2022 TAX SEASON

I have decided that I will continue to avoid face-to-face meetings with my clients this year during the 2022 tax filing season. Just like this past 2021 tax filing season, we can use the mail, e-mail, fax, or front door drop off / pick-up.



IRS BACKLOG

As of December 10, 2021, the IRS had a backlog of 6.2 million unprocessed individual tax returns. Many of these are 2020 personal income tax returns mailed to the IRS rather than e-filed. Unfortunately, if you are one of the many people still waiting for your refund, there is nothing I can do to speed up IRS processing. The best way to avoid this problem with your 2021 tax returns is to file early and file electronically.

STIMULUS PAYMENTS, AND ADVANCE CHILD CARE CREDIT

The IRS requires taxpayers (YOU) and tax professionals (ME) to reconcile the amounts of (1) the 2021 stimulus payment you received and (2) any Advance Child Care Credit that your received with the amounst that IRS shows that they sent to you. If not properly reconciled (generally, if IRS records show that they sent money to you, but you say that you did not get some or all of those payments) the IRS may hold the return for manual processing, causing delays in refunds (See prior article!).



- 1. IRS sent letters (**IRS Letter 6475**) to all those who received the 3rd stimulus payments in March May 2021. <u>Please give me a copy of that letter</u>.
- The Advance Child Care Credit: IRS sent letters (IRS Letter 6419) to all those who received Advance Child Care Credit payments in 2021. <u>Please give me a copy of that letter</u>. (Note: This only applies to taxpayers with children age 17 or younger.)

If you do not have copies of those letters, it may involve a lot of work to reconcile what you should have received and what you actually did get. That would mean more work for me, a higher fee to you, and delays in getting your federal refund.

2022 STANDARD MILEAGE RATES

Beginning January 1, 2022 standard mileage rates for the use of a vehicle will be

- 58.5¢ per mile for business miles driven (up 2.5¢ from 56¢ for 2021);
- 18¢ per mile driven for medical purposes (up 2¢ from 16¢ for 2021);
- 14¢ per mile driven in service of charitable organizations (unchanged).

IRA / 401(k) / 403(b) CONTRIBUTION LIMITS FOR 2022



- <u>Individual Retirement Accounts:</u> The 2022 contribution limits remain **\$6,000** for traditional IRAs and Roth IRAs, and catch-up contributions for people who are 50 or older are still \$1,000.
- <u>401(k) and 403(b) Plans</u>: The amount you can contribute to a 401(k) plan or a 403(b) plan for 2022 increased to **\$20,500**. If you're age 50 and older, you can add an extra \$6,500 in "catch-up" contributions, bringing your total 401(k) or 403(b) plan contributions for 2022 to \$27,000.

NEW REQUIRED MINIMUM DISTRIBUTION (RMD) TABLE FOR 2022 AND BEYOND

For the first time in 20 years, the Internal Revenue Service has updated its Uniform Lifetime Table. This table is used to calculate RMDs from individual retirement accounts, 401(k)s and other retirement savings vehicles each year.)

The updated table projects longer lifespans. (The average life expectancy was raised from 82.4 to 84.6.) The result is that retirees can spread their assets over more years, resulting in lower RMDs each year.

For example, a 72-year-old with \$500,000 in their retirement account would have been required to withdraw \$19,531 in 2022 under the older formula. However, the updated formula results in a RMD of just \$18,242.



The good news is that individual taxpayers do not have to do the calculations on their own. The custodian (bank or other financial institution) that manages your IRA account will do the calculation for you, and tell you that amount each year. You can certainly withdraw more from an IRA or 401(k), but <u>if you take out too little,</u> the shortage is subject to a 50% penalty. And remember, whatever amount you take out is subject to ordinary income taxes.

Also, remember that Roth IRAs are not subject to RMDs.

ANNUAL GIFT TAX EXCLUSION

Beginning January 1, 2022, the amount that you can give away without tax consequences increases to \$16,000. (The amount was \$15,000 in 2021.) That means that each individual gift cannot exceed \$16,000. But you can give up to \$16,000 to multiple people without tax consequences.

In any event, <u>the receiver of the gift pays no income tax</u>, regardless of the amount of the gift they receive. However, if any individual gift exceeds the limit stated above, the giver of the gift should file a Gift Tax return, and may have to pay tax on the amount exceeding the limit.

Note: The above limits are <u>calendar year</u> limits. You could make a \$16,000 gift in December 2022 to a person and then make another \$16,000 gift to the same person in January 2023, with no tax consequences. And your spouse could do the same thing, too.

THE THIN BLUE LINE, by Patrick Youells

I was going to write an article that was funny to read. However, this past week has been a bad month not just for the BPD but also police on a national level. After research, I found out how wrong I was. It not only has been a bad week, but has been a terrible year for Police across this country.

Line of Duty Deaths, according to The Officer Down Page. These deaths that are LOD include accidents and Covid. The statistics that come out loud and clear are the ones that were caused by the criminal element.

Total Line of Duty Deaths for 2021:

9/11 related illness: 3 Assault: 5 Gunfire: 62 Stabbed: 3 Struck by vehicle: 14 Vehicle pursuit: 3 Vehicular assault: 17

I removed accidents and Covid from the list along with heart attacks, LOD Illnesses. I left 9/11 deaths in as they were caused by a criminal act.

The new total is 107.

Compare this with the prior year of 60 and you see there was a 42% increase.

I list these ways our Brothers and Sisters in Blue have died due to the actions of a criminal to give you a better idea of what the active Police go through. There is a war on not just police, but on society as well.

Years ago I was in criminal court, you know the place where real States Attorneys use to work. I had an assault on Police case. The S/A made this statement to the Judge and Jury. She said," When someone assaults a Police Officer they are not just assaulting the Officer, but society as well".

Everyone that reads this will remember friends, side partners or coworkers that died a violent death at the hands of a criminal. For me, I tend to take these deaths hard. The problem is that these deaths make me remember the people that I knew that were murdered doing what I was doing. It brings back the memories of the families being handed a folded American Flag at the conclusion of the graveside service.

When I was assigned to the Southwestern as a Sergeant, the first Officer to die was a young man named Kevon Gavin. The next day the Police Commissioner, Ed Norris, came by to talk to the members of the Flex Squad where Kevon worked and everyone else that was in the stationhouse. As Commissioner Norris spoke, he began to tear up. He apologized and said this, "I did not know Officer Gavin. I am in tears not just for him and his family, but it has a deep affect on me. I remember the fellow officers I lost in my 20 years in the NYPD."

A few years later, Officer Brian Winder was gunned down serving the community in which he grew up. Brian's funeral was held at the Cathedral of Mary Our Queen. As the service ended, the open casket was slowly closed. During that pause, Brian's 7-year-old yelled out "I want my Daddy." That memory has stayed with me.

My point is this. We all know Police work is a dangerous profession. It always has been. However, the continued decline in the moral fiber of this country makes Law Enforcement even more dangerous. You add in manpower issues and Consent Decrees, as Baltimore City is under, and you get a very difficult job being made even more difficult and dangerous. This does not include when the Officers of the BPD must contend with the current States Attorney who cherry picks what crimes her office will prosecute.

Each day, in fact, every five hours, an Officer dies in the line of Duty from everything from Assaults to Covid. The Thin Blue Line has never been thinner.

We Lost a Friend

Many of you younger retirees will not know who I'm about to write about, but for us older folks, I'm going to write about a dear friend.

On January 13th, 2020, Robert Limmer passed away. He was a regular guy, a good guy. He was born and raised in Rosedale and graduated from Overlea High School in 1964. During that time, he also worked at his family's store on Chesaco Avenue in Rosedale.

His family also owned a shore home and that began Bob's love of water, so it was only fitting that after graduation, he joined the Navy. While home on leave in 1966, he married his sweetheart, Linda (who graduated from Overlea High School one year after him), before returning to the Navy and finishing his tour of duty. When he left the Navy, he still carried that love for his service, and joined the Navy Reserve.



Bob and Linda had two boys, Robert, Jr., and Greg, and eventually, three grandchildren and one great grandchild. Bob and Linda lived in Middle River, right on the river. He truly did love the water.

In 1971, Bob joined the Baltimore City Police Department. He worked in the Northeast District before being transferred to the Motor Pool. In 1991, Bob retired from the Police Department and he and his wife Linda bought Libertini's Restaurant in the Parkville Shopping Center and changed the name to Heritage Gardens Parkville.

Bob and Linda ran the Heritage Gardens until 2017 when their landlord changed the terms of their contract, insisting on a ten-year contract and tripling the rent. This was astronomical to Bob and Linda, so they made the decision to retire from the catering business.

The BRPBA was fortunate to be able to hold their meetings at the Heritage from 1991 to 2017. Bob and Linda <u>always</u> extended great service and delicious food to the BRPBA at a reduced price. Even in retirement, he remained true and loyal to his Brothers and Sisters in Blue.

After retiring from the catering business, Bob started making fishing lures with the hope that he would one day be able to start a business, but life intervened and Bob got sick.

I went to high school with Bob. We graduated together, and we, along with five other Overlea High graduates, joined the BPD.

He will truly be missed.

WOMEN IN POLICE WORK

In 1970, most agencies, including the Baltimore Police Department, relegated women to secondary roles. The traditional "wisdom" back then held that, as the so-called fairer sex, they simply could not handle conventional law enforcement tasks, either physically or emotionally. Then, when finally, later in the decade, they broke through the official impediments to functioning in all law enforcement capacities, many of their contemporaries viewed them as novelties. Even today some perceive women as lacking, simply because of their gender. They are wrong.

In 1981, a Colorado police officer, Debra Sue Corr, stopped a pillar of the community for a traffic violation. The situation escalated to such an extent that the officer attempted to arrest him. He broke free, took her weapon, and killed her. He later killed himself. On January 29, 2022, over 40 years later, the Washington Post identified the female officer's murderer as a serial killer of women through DNA analysis.

Over 40 years later, on January 7, 2022, the Denver Post reported that another female law enforcement professional, Agent Ashley Ferris, was released from the hospital after being shot in the abdomen on December 27, 2021 by an individual who had killed 5 people in Denver and neighboring Lakewood, Colorado. That individual will never stand trial, however, because Agent Ferris shot and killed him.

In Bradley Illinois, a Chicago suburb, the End of Watch for Sgt. Marlene Rittmanic occurred in December, 2021. She and another police officer responded to a report of dogs barking in an unattended vehicle at a Comfort Inn. They found the room where the vehicle's possible owner was staying and were shot talking to people in the room. Sgt. Rittmanic died.

In January, 2022, Hazelhurst, MS Police Officer Laquandia Cooley responded to a shooting. When she arrived, she found that her son, Charles Stewart, Jr., was the victim. Shot in the head, he died. Officer Cooley naturally removed herself from any further involvement, but she continues to protect and to serve.

On December 22, 2021, Charlotte-Mecklenburg Police Officer Mia Goodwin, originally from Passaic New Jersey, died as a result of injury she sustained while investigating a traffic accident on Interstate Highway 85. She left behind a husband and 3 children, all younger than 4 years old.

On November 5, 2021, Police Ofc. Lena Nicole Marshall, a Jackson County, Georgia, Sheriff's Deputy, was shot when she responded to a domestic disturbance at a home in Hoschton, about 50 miles northeast of Atlanta. She died 3 days later.

Much closer to home, on May 21, 2018, Baltimore County Police Officer Amy Caprio, responding to a call, encountered an individual in a stolen vehicle who was acting as a lookout and as transportation for several other burglars. Completely by herself at that point, she tried to stop the individual from leaving. He ran her over and killed her. She was the first female Baltimore County Police Officer ever killed in the line of duty, and she remains with us today in spirit.

About a year later, in May, 2019, Baltimore County Police Officer Tabitha Hays, a fifth generation police officer, the daughter of Sarasota, Florida, Police Chief Bernadette DiPino, the granddaughter of Retired BPD Major Charles "Spunky" DiPino, and the great granddaughter of Captain James DiPino, a consummate gentleman who commanded the Southwest District of the BPD, received a serious gunshot wound after she and other officers encountered an individual attempting a "suicide by cop." Struggling valiantly with her injuries, she overcame them after a convalescence of months and returned to the County Police to continue the family tradition.

In Baltimore City, the first female law enforcement fatality occurred almost 16 years before Baltimore County's. In August 2002, Baltimore Police Officer Crystal Sheffield, who earned the respect of her fellow police through her constant physical initiative in running down dark alleys and backing up other police, to list just a couple, responded to a Signal 13 to assist an officer in trouble. She never made it, dying when an unmarked police car responding to the same emergency struck her vehicle. She left behind a Baltimore Fire Lieutenant husband and children and, like Officer Hays, came from a police family dedicated to service.

In the second decade of the current century, Baltimore has witnessed an unremitting carnage of senseless homicides, and tragically, a female law enforcement professional became a recent victim. On December 23, 2021, a week after 2 criminals with extensive records ambushed her from behind and shot her, her family made the difficult and excruciating decision to discontinue her life support. Shortly thereafter, her heart, which had never failed anyone else, not her family, not her children and certainly not the citizens of Baltimore for whom she took the difficult job of policing to help, failed her. She left behind a legacy of selfless altruism to which all true police aspire.

What is abundantly apparent from all these anecdotes is that good women make good police officers. In the Baltimore Police Department, women have achieved success at every level, including the very highest. In fact, the female Chief of the Baltimore County Police Department spent an entire career with the City Police, excelling at every level.

Fifty years ago, the greatest majority of agencies relegated women to secondary, and in some cases menial, roles. No longer is that the case; nor should it be. In fact, the presence of women, and the jobs they do well, benefit both the Department and the citizens it serves in these troubled times.
