I want to start with an apology. I am sorry for the unconstitutional, the Mayor had a bill introduced lateness of this newsletter. The fault lies solely at my feet. Was that spiteful? distance from Baltimore and for some, this newsletter is your primary source of news about Every year insurance rates rise, cost of co-pays the many important matters that are of deep concern to you.

At this time, the big concern to all of us is the pension suit. We have received notice that our appeal, which will be heard by the 4th Appellate Court, is scheduled for May 14, 2014 in Richmond, VA. Keep in mind that it could be months before a ruling is issued. Each side will be limited to 20 minutes in order to argue their appeal. Doesn't seem like enough time for such an important matter. I have been told that a full transcript of the hearing will be posted on the Courts' website within three days of the argument. We have made many attempts to settle this matter by negotiations with the City, but the City does not seem to want to sit down with us and reach an agreement. The City was offered something less than what I would consider our bottom line in the first place. The City already feels that we are asking too much; anything they would offer us would be way below what would be acceptable and meet our needs. It seems to me that the Mayor has decided to cure the ails of the City on the backs of its retirees. Then, because we had a partial victory in our court suit stating that the COLA provision that was based on age was

for medications also rise and formularies are changed causing medications that we have taken for years to be placed in a higher classification, which again causes the price to increase. Where it stops nobody knows.

While this happens, the Mayor pushes tax breaks for major corporations that deprive the City of hundreds of millions of dollars in revenue. This is money that could be used to pay its debts instead of breaking a contract with it employees. Developers who own valuable waterfront property in Baltimore are going to build whether the city gives them a tax break or not. They already have too much time and money invested to guit a project. These are the same people who will demand enormous services from the City while at the same time pay little or no taxes. Just look at all the money spent to protect the businesses around Harbor Place.

The City already has too many hotels and only on very rare occasions will anyone have trouble finding a room. So what does the Mayor do? Why she builds a great big hotel in downtown Baltimore. Yes, the City of Baltimore is the proud owner of a big hotel and it loses money

A FAMILY'S TRAGEDY

A house fire that occurred on March 6 in the 2900 block of Glendale Avenue, in Parkville, MD, took the life of Tracy Lynn Williams. Tracy was instrumental in saving the lives of her mother, Margie McCallister and her daughter, Emily McCord, but succumbed to her injuries from smoke inhalation at Bayview Medical Center on March 7, 2014. Tracy was an organ donor and her organs were harvested at the time of her death. Tracy's liver, corneas and bone marrow were able to save four lives. Tracy was truly a giving person. If it wasn't for Tracy, all three would have perished in this awful fire.


Margie McCallister is the widow of the late William "Mac" McCallister; a BRPBA member who passed in 2006. Mac retired from the NE District on March 8, 1995.



They donated the costs of Tracy's care and viewings. A family member of Tracy's contacted Dulaney Valley Memorial Gardens who donated a burial plot and funeral services. We are extremely grateful to both of these fine businesses for helping this family who lost everything in this devastating fire.

F & P TRUSTEE NEWS

Re: F&P Board Meeting, March 18, 2014

Today's F&P Board meeting was of particular interest that will continue what I believe is a very positive benefit for all F&P retirees and beneficiaries.

But first, as of February 28, 2014, the assets of our fund stand at \$2,440,861,841. That is up 8.82% for the fiscal year and 1.73% for the calendar year.

You may remember last year I advised that the administration of the F&P wanted to go to paying us on a monthly basis. This would mean getting paid 12 times and year and doing away with our getting paid 26 times a year. Apparently they get a lot of calls regarding missing checks, incorrect checks and normal snafus that go along with the issuance of more than 6,000 checks every two weeks. Going to monthly checks would cut back on those aggravations considerably. They also said going to a monthly pay would save more than \$137K. It should be noted that the administrative expenses for the F&P are part of the City's annual contribution to the fund and do not come directly from investments.

For today's meeting, they had provided the board members with a PowerPoint presentation that showed where the cost savings would come and provided numerous reasons why it would be good to go that route. I received the presentation last Friday and during my review I checked their calculations. Using their numbers, my result came differently than theirs by \$36,000. However, that \$36K added to the projected savings to the F&P. They made the corrections in time for their presentation to the Board. Total savings would be \$173,681 per year. The plan called for the change to be made January 1, 2015. We would then receive our first monthly check January 15th and the 15th of every month thereafter. It would cover the first two weeks of the month that preceded the check and the next two weeks that were coming up. So two weeks of that check would have been an advance. A positive effect would be that when a primary dies, his/her beneficiary would not have to return the money that was paid in advance of the death. He/she could keep the extra payment and then receive the survivor benefit the 15th of the next month.

During the discussion an issue came up that was not in the PowerPoint presentation that would only affect active members when they retire. Right now the last working day of a member can be any day of the month and as long as the member provides a window of 30 days. Then when the first retirement check is received, it will pick up after the last working day. However, the new plan would mandate that the first retirement period start on the first of a month. So if a member wanted to retire, for example, on the 14 of a month, he/ she would not receive retirement pay for the remaining days of that month.

That is an issue that could be prevented through proper planning, but would still take away some discretion on the part of the member.

During the presentation and after, we had discussions as to the pros and cons, and the legitimacy of the Board making such a request to the City. I voiced my contention that the bi-weekly pay was a benefit to the beneficiaries and was not something the Board should recommend eliminating. It was my opinion that if the City wanted to do this, they should negotiate the issue with the unions.

When it was time for the vote, the proposal to recommend to the City to change the City Ordinance to go to a monthly payroll was defeated 6 to 5. So the proposal will not go forward at this time. However, today's action does not mean the City Administration will not present this to the City Council. And if that happens, it will be up to the unions and retiree associations to convince the Council not to pass the ordinance.

That's it for this time.

As of 2013, the State is only allowing licensing electronically. The website address is: MDSP.org. When you go into this site, click on Licensing Division on the left hand side, click on the picture "Firearms" in the center of the page, and then click on Wear and Carry Permit on the left hand side. From there, you can follow their step-by-step instructions.

Unfortunately, if you do not have computer access, you will need to either go to the library to do this, or have a friend or family member help you.
