PRESIDENT'S MESSAGE

A little late, but... Happy Birthday to the USA. We've made it a whopping 245 years as a country. Let's hope we make it another 245 years. To our military past and present who have fought for the freedoms of this country all these years, we thank you. We would be remiss if we didn't also send out a thank you to all fire and police, past, and those during the present who fight a hard fight every day to protect us, despite the current pressure. We do remember the struggle of the job, and it's gotten even harder for this generation.

- In other news, we received word about an interesting organization, and it intrigued us, so we contacted "**The Wounded Blue**", a non-profit peer supported group of police officers. They are not affiliated with any police organization. - I received a request to aid retirees trying to obtain a new police ID. Currently, you have to appear in person in order to obtain an ID. It's darn near impossible for out of state retirees and any members with mobility issues to get downtown; and two of the biggest concerns we retirees' face when we venture downtown are parking and crime. This system needs to be streamlined, and it would be beneficial for all if we could do this online or by mail. Our ID, as you know, is not only needed for gun permits, but also if you get stopped and you have to tell the policeman you are carrying.

We contacted Chief of Staff to the Police Commissioner, Eric Melancon, and the Office Manager for BPD, James Gillis, on June 24th about this issue. Mr. Melancon responded immediately, stating that he would "look into the matter". We did not hear from Mr. Gillis. As of this moment, we have not received any further correspondence. Imagine that. We will not let this matter go unsettled. Thank you, Jeff Rosen, for bringing this to my attention.

- I have received a lot of calls and emails about Aetna insurance and I'm taking this opportunity to set the record straight. Active and Retired Police and Firefighters are not responsible for the switch from Blue Cross/Blue Shield to Aetna Insurance. We privately

spoke with Aetna about obtaining a Medicare Advanced Plan for retirees because Blue Cross/Blue Shield did not have a Medicare Advanced Plan at that time. The city got wind of our discussions, somehow, and interfered, saving themselves ten million dollars by switching without us knowing they had even talked with Aetna.

With that in mind, we are concerned about our future healthcare. Our pension and healthcare need to be preserved. On 7/6/2021, all City Unions met in person or via phone at the Firefighter's O'Donnell and Linwood station. We voted unanimously to have Frank Boston be our lobbyist and to speak to Mayor Scott one on one and advise the Mayor that we are going ahead with legislation to guarantee our healthcare. Frank Boston has been the BRPBA and FOP lobbyist for years and has done an excellent job. He will represent us well with our healthcare concerns. We will all split his costs for representing us.

- We still have the \$50.00 finders fee in place for any member who signs up a new member. This seems to be working well, so why don't you try it out?

MARSHALL HAMILTON

On October 7, 1897, Capt. Samuel T. Hamilton was elected Marshal of Police to succeed Marshal Jacob Frey. Marshal Hamilton was a veteran officer of the Civil War and a man of indisputable courage and integrity. For many years following the Great Civil Conflict he had served on the Western frontier and took part in the unremitting campaigns against the Sioux and other Indian tribes that were constantly waging war upon the settlers and pioneers as they pushed their way toward the setting sun building towns and railroads while trying to conquer the wilderness and its natural dwellers.

In the Sioux campaign of 1876, when Gen. George A. Custer and his command were outnumbered ten to one by the Indians in the valley of the Little Big Horn and were annihilated, Captain Hamilton and his troop rode day and night in a vain effort to re-enforce Custer and his sorely pressed men. It was on 26 June 1876 when the 7th United States Cavalry rode and fought to their deaths, and on the 27 of the same month, just 1 day after the Battle at Little Big Horn, reinforcements arrived, exhausted from their terrific ride across the country.

Captain Hamilton and his troops fought through the rest of the campaign, which resulted in Crazy Horse and Sitting Bull, the great Indian war chief, being driven across and into the Canadian frontier. Marshal Hamilton brought to his office pronounced ideas of a semi-military discipline for the police, (what is today called a paramilitary organization) and it may be said that many of the military forms which were adopted under his administration have been of great service to the Department in the matter of the individual carriage and conduct of its members while on the street.

Ex-Marshall Hamilton, after ceasing his connection with the Police Department, was raised to the rank of Major in the United States Army and granted a pension commensurate with that rank. Accustomed to an active life, he requested the War Department to give him employment, and he was assigned to take charge of the army recruiting district, with headquarters in Harrisburg, Pa., where he died in 1906.

STILL WAITING FOR YOUR 2020 TAX REFUND?

Many taxpayers are still waiting for their tax refund. And when they go to the IRS website (www.irs.gov) and click on "Get Your Refund Status" they are told their return is being processed. I know this is very frustrating, but unfortunately there is nothing we can do about it.

The primary causes are the staffing shortages (as of March 5, the IRS had 4,434 unfilled processing positions), tax law changes that were passed in February 2021 but which were effective retroactive to January 1, and problems with IRS printers - many printers are in need of service, with no one to fix them. (This sounds far-fetched, but it is true.)

The pandemic shut down IRS offices. Then IRS had to send out **tens of millions of stimulus payments**, which diverted their time away from processing tax returns. IRS has been playing catch-up ever since. In fact, the Treasury Inspector General found that at the end of 2020 more than 8.3 million individual 2019 tax returns and transactions remained to be processed, and as of June 30, 2021 the IRS said it had 35 million unprocessed individual returns (including 2020 returns) in the pipeline.

There's nothing that you or I can do to speed up the process. Definitely don't file a second return, and don't **bother calling the IRS** about when you should expect to get your refund. There's nothing you can do but wait and keep checking "Get Your Refund Status".

CHILD TAX CREDIT (CTC)

Advanced Child Tax Credit Payments are supposed to be sent to eligible taxpayers beginning in July 2021. If you receive these payments, please keep a record of how much you received and when you received the payments, and then give that information to me when I prepare your 2021 tax returns. And if you get a letter from the White House telling you that you will be getting Advanced Child Tax Credit payments, please keep that letter also.



Note: The Advanced Child Tax Credit Payments are an advance on what you normally would receive in 2022 after you file your 2021 tax returns. **If you get the Advanced Child Tax Payments in 2021, you will not be able to claim those credits again in 2022 when we file your 2021 tax returns.**

This can be a problem if you have gotten the child tax credit in previous years. By getting the "Advanced Credit" in 2021, that credit cannot reduce your total taxes when you file in 2022. You will get the money in 2021, or you will get the credit in 2022, but not both. So, if you have gotten the Child Tax Credit in previous years but get Advanced Child Tax Credit payments this year, you will get a smaller refund in 2022, or you might even owe taxes in 2022.

If you don't understand the above, call me to discuss this issue.

EARLY WITHDRAWALS FROM YOUR IRA OR RETIREMENT PLAN

As I mentioned in my April Newsletter, Required Minimum Distributions are again required in 2021.

In 2020 Congress also granted a one-time special “Covid exception” to the 10% penalty for early withdrawals from retirement plans and IRAs. This exception was for 2020 only.

There is no COVID exception in 2021 from the 10% early withdrawal penalty. So, if you take an early distribution from your IRA, 401(k) plan, 403(b) plan, etc., and you do not meet one of the exceptions, you will be liable for the 10% penalty.

VACATION HOME INTEREST DEDUCTION

When buying a vacation home, you might have a choice between taking out a (new) mortgage on the vacation home, or getting a home equity loan on your primary residence. (A home equity loan probably will have a lower interest rate.) BEWARE! You should not automatically take the lower rate home equity loan without first evaluating your tax situation.

To deduct the interest payments, you must use the money from the home equity loan to buy, build or “substantially improve” the home that you used to get the home equity loan. If you use a home equity loan on your primary residence to purchase a second home, the interest on the home equity loan is not deductible. But if you take out a mortgage on the second home, the interest on that mortgage is deductible, because the interest on that mortgage is associated with the loan used to buy the second home.

If you expect to itemize deductions on your future tax returns, you may be better off taking out a mortgage on the vacation home, even though the interest rate may be a little higher. If you expect to take the standard deduction, however, then go with the home equity loan. Do your homework first, then decide.

UNEMPLOYMENT BENEFITS



In February 2021, Maryland passed the Maryland Relief Act making all of your 2020 unemployment benefits tax-free if your 2020 Federal Adjusted Gross Income was less than \$100,000. Then in March 2021, the federal government passed the 2021 American Rescue Plan Act making up to \$10,200 of 2020 unemployment benefits tax free if your 2020 Adjusted Gross Income was under \$150,000

Please be aware that these changes to the taxation of unemployment benefits were applicable to 2020 only. Consequently, all unemployment benefits received in 2021 are fully taxable by IRS and by Maryland.

- ⇒ All conversations are confidential.


Information I have copied from their main page includes: The Wounded Blue supports officers who were injured on the job by helping them complete the Public Safety Officer Benefit application. They also have "Camp Blue", which is a retreat for injured and disabled officers. They provide training to Law Enforcement Leadership and Rank/File Officers regarding the mental and physical issues facing injured and disabled officers. They provide emergency financial aid, mental/emotional health treatment referrals, legal assistance referrals, membership benefits of medical/dental discounts, and access to private anonymous mental health treatment. And lastly, they fight for stronger laws and protections for injured Law Enforcement Officers.



RECENT INTERESTING DECISIONS
Recently the Court of Special Appeals issued a couple of
fascinating opinions.

THE UNSUCCESSFUL HAIL MARY

In *Dejarnette v. State*, Md. Ct. Special App., No. 2316, September Term, 2019, decided July 6, 2021, a State Trooper stopped Alexander Dejarnette on April 6, 2019 at 1:59 AM when he changed lanes without using a signal and then slid onto the shoulder of the road before he jerked his vehicle back into the lane in front of the trooper's car. The trooper smelled alcohol emanating from the vehicle and saw that Dejarnette's eyes appeared bloodshot and "glossy." When Dejarnette exited the vehicle, the trooper smelled alcohol on his breath, and he admitted having had some drinks hours earlier. He performed poorly on the field sobriety tests conducted on the side of the road, so the trooper arrested him at 2:12 AM. The trooper then searched Dejarnette's mouth and pockets, handcuffed his hands behind his back and put him in the front passenger seat of the police car.

They arrived at the Princess Anne Barracks at 2:21 AM where Sgt. George Todd, the duty officer, met them. The arresting trooper, Trooper Brown, conducted another search of Dejarnette in Sgt. Todd's presence, finding nothing. He placed the contents of his pockets in a plastic bag and escorted him to a processing room. From 2:21 AM to 2:37 AM, Brown and Dejarnette were together in the processing room, 8' x 10' with 2 small chairs. Dejarnette was not handcuffed while he was seated in the processing room. After the trooper read him his rights, Dejarnette agreed to take a breath test, which began at 2:43 AM. The trooper never saw him drink or smoke anything or put anything in his mouth, and the two readings obtained both showed a .094% blood alcohol concentration.

Before trial, Dejarnette filed a Motion in Limine arguing that the results of the breath test had to be excluded at trial because a COMAR regulation required that defendants be observed for 20 minutes. The Trial Court denied the motion, determining that both Trooper Brown and Sgt. Todd observed Dejarnette for 20 minutes before he got the test, that neither observed any behavior that would invalidate the test, and that any challenge to compliance with the 20-minute observation period, specified in a COMAR regulation, went to the weight of the evidence and was therefore admissible at trial. Dejarnette got a conviction of driving under the influence of alcohol per se, i.e., that he had an alcohol concentration of at least .08%, and he received a sentence of one year incarceration with all but 10 days suspended and probation for a year as well. He then appealed.

The Court of Special Appeals of Maryland rejected the argument that the test for alcohol concentration had to be excluded because the State could not prove that the police had observed Dejarnette for 20 minutes. The Court noted that under Md. Cts., & Jud. Proc. Code S 10-309, there must be strict compliance with the express provisions of the *statute* (such as the provision of 10-303 that a test be administered within 2 hours of an arrest) *not* a COMAR *regulation*. The plain language of the law does not require strict compliance with State regulations, so any violation of a State regulation does not trigger an exclusionary rule. The power of an administrative agency does not extend to determining if evidence is admissible in court. It cannot unilaterally create an exclusionary rule in a regulation. Moreover, compliance with the COMAR regulation here, ostensibly requiring 20 minutes of observation, does not require a police officer to stare continuously with unbroken eye contact at a suspect for 20 minutes. It is reasonable to permit officers to use all their senses to observe whether an individual drinks, eats, smokes, puts something in his or her mouth or, for that matter, regurgitates prior to administration of the test. The Appellate Court further noted that compliance with a COMAR regulation goes to the weight of the evidence, not its admissibility. A defendant has an opportunity to offer evidence challenging the reliability of the results. If defendants provide "less compelling indicia of reliability," then the judge has the discretion to permit the evidence. At trial, the jury is permitted, not required however, to disregard the evidence of a breath test if they believe it was not administered properly or if, in the administration of the test, the police failed to comply with the COMAR regulations.

BARKING UP THE WRONG TREE

In *Latz v. Parr*, Md. Ct. Special App., No. 977, September Term, 2019, decided July 6, 2021, the Court of Special Appeals reversed a Howard County matter in which neighbors utilized the court system to fight like cats and dogs when the defendant's dog got loose and chased the plaintiff's cat into the plaintiff's home. The plaintiff in an attempt to rescue her cat, who was cowering under a bed, grabbed the dog who struggled mightily, causing the plaintiff's husband to jump from the shower, grab the animal and eject it from the premises. Some hours later, the plaintiff began to experience pain. She then sued both Jacob Parr and his significant other of over 9 years, one Vicki Nichols, who used to bring the dog with her when she drove from her home in New Jersey to Maryland to visit Mr. Parr. After she got sued, Ms. Nichols filed for bankruptcy, and Ms. Latz dismissed the case against her.

A jury trial began on June 25, 2019, and on the second day, the Trial Judge entered a judgment in Mr. Parr's favor on the basis that he did not own the dog. Mr. Parr had made that argument not only at trial, but also before trial in motions he filed then. The Court of Special Appeals, in analyzing Mr. Parr's arguments, ultimately determined, in reversing the case, that Mr. Parr was barking up the wrong tree.

Prior to April 1, 2012, recovery for injuries caused by a dog could be pursued under theories of both negligence and strict liability by which it would not even be necessary to show negligence, but that only occurs when an owner or keeper of a dog has actual or constructive knowledge of its dangerous propensities. In an ordinary negligence case, the negligence that exposes an animal owner who is unaware of the animal's dangerous propensities is the failure to control the dog or to prevent the harm caused by it. The decision also noted that the Court of Special Appeals of Maryland has looked to animal control statutes in determining if a particular defendant's violative conduct was evidence of negligence. For instance, *Moura v. Randall*, 119 Md. App. 612, 647 (1998) considered whether a defendant violated a Montgomery County code prohibiting an owner from permitting a dog to run at large, and in *Hammond v. Robins*, 60 Md. App. 430, 437, the court commented that the "appellant violated the Carroll County Animal Ordinance by not keeping the dog under restraint and by allowing the dog to leave the property unattended and unrestrained." *Id.*

In this case, the Court noted that merely permitting a dog to remain on one's property may not be enough to establish ownership. But, exercising some degree of care and control of a dog on one's premises may be sufficient to establish liability. In this case, the Trial Judge's decision to grant Mr. Parr's motion effectively deprived Ms. Latz of a jury determination. Denied her full day in court, she won at least the right, at this point in any event, to let the jury decide if she should recover.



BALTIMORE RETIRED POLICE BENEVOLENT ASSOCIATION TAG PROGRAM




