Doggie Daycare General Information and Policies

Health, Behavior & Financial Policies Statement

The purpose of Stay and Play Doggie Daycare LLC (“Doggie Daycare”) is to provide a safe, fun and stimulating social environment for dogs during weekday business hours. To ensure the safety and health of your pet and our other guests, we require all guests and their owners to comply with the following policies:

SEX: All dogs 9 months or older must be spayed or neutered.

SHOTS: All dogs must have up-to-date vaccinations. Owners must submit written proof of DHLLP, Bordetella (kennel cough) and Rabies vaccinations.

HEALTH: All dogs must be in good health. Owners will certify their dog(s) are in good health and have not been ill with a communicable condition in the last 60 days. Upon admission, all dogs must be free from any condition that could potentially jeopardize other guests. Dogs that have been ill with a communicable condition in the last 60 days will require veterinarian certification of health to be admitted or readmitted.

BEHAVIOR: All dogs must be non-aggressive toward food and/or toys. Owners will certify their dogs have not harmed or shown aggressive or threatening behavior towards any person or any other dog(s). Dogs showing aggressive behavior toward any other dog and/or person (including staff or customers) will be excused from daycare with no refund of prior payment. If your dog causes an injury to another dog and/or staff, you as the owner will be responsible for any and all medical treatment needed. Please remember: your dog will be spending time with other dogs, and the safety and health of your dog and our staff is our main concern.

APPLICATION: All dogs must have a complete up-to-date and approved application on file.

FEES: Fees are based on a pass plan. A pass is valid for 90 days from the date of purchase. Additional dogs are \$21 per day per dog.

1 day pass:	\$28.00
5 day pass:	\$125.00
10 day pass:	\$240.00
20 day pass	\$460.00

DAYS & HOURS: Monday through Friday from 6:30 am to 6:00 pm. Doggie Daycare is not an overnight facility. Staff goes off duty at 6:00 pm and there will be a \$1.00 charge for every 5 minutes pets are left after 6:00 pm.

RESERVATIONS: Required. Cancellations with less than 24 hour notice will be charged full fees.

DROP OFF POLICY AND PROCEDURE:

Your dog is excited to arrive; and tired but happy, to see you at the end of the day. Please follow the procedures outlined below for the safety of your dog, our employees and you.

1. When entering, do so quietly and calmly, hand the leash to the attendant and exit the building quietly as well.
2. When picking up your dog, please follow the same procedure.
3. We know you are happy to see your dog at the end of a long day, but please do not approach or talk to the dogs in the outdoor enclosure.

We require that all dogs arrive by 9am and no later.

Relax and enjoy the day knowing that your best friend is being well cared for, having fun and making new friends.

Owner Liability Waiver and Health Certification

I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending Stay and Play Doggie Daycare. (“Daycare”)
2. I further understand and agree that in admitting my dog(s) to the Daycare, Stay and Play’s staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggression towards any person or any other dog.
3. I further understand and agree that Stay and Play Doggie Daycare and their staff will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog’s/dogs’ attendance and participation at the Daycare.
4. I further understand and agree that dogs can sometimes receive minor cuts and scratches at daycare and any problems that develop with my dog(s) will be treated as deemed best by staff of Stay and Play Doggie Daycare, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved.

I certify that I have read and understand the policies of the Daycare as set forth on the preceding pages and that I have read and understand the conditions, and statements of this agreement, including the following:

DAYS AND HOURS: Monday through Friday from 6:30am to 6:00pm. The daycare is not an overnight facility. Staff goes off duty at 6:00 pm and there is a \$1.00 per 5 minutes charge for any pet left after 6:00 pm.

RESERVATIONS: Required. Cancellations with less than a 24 hour notice will be charged full fees.
