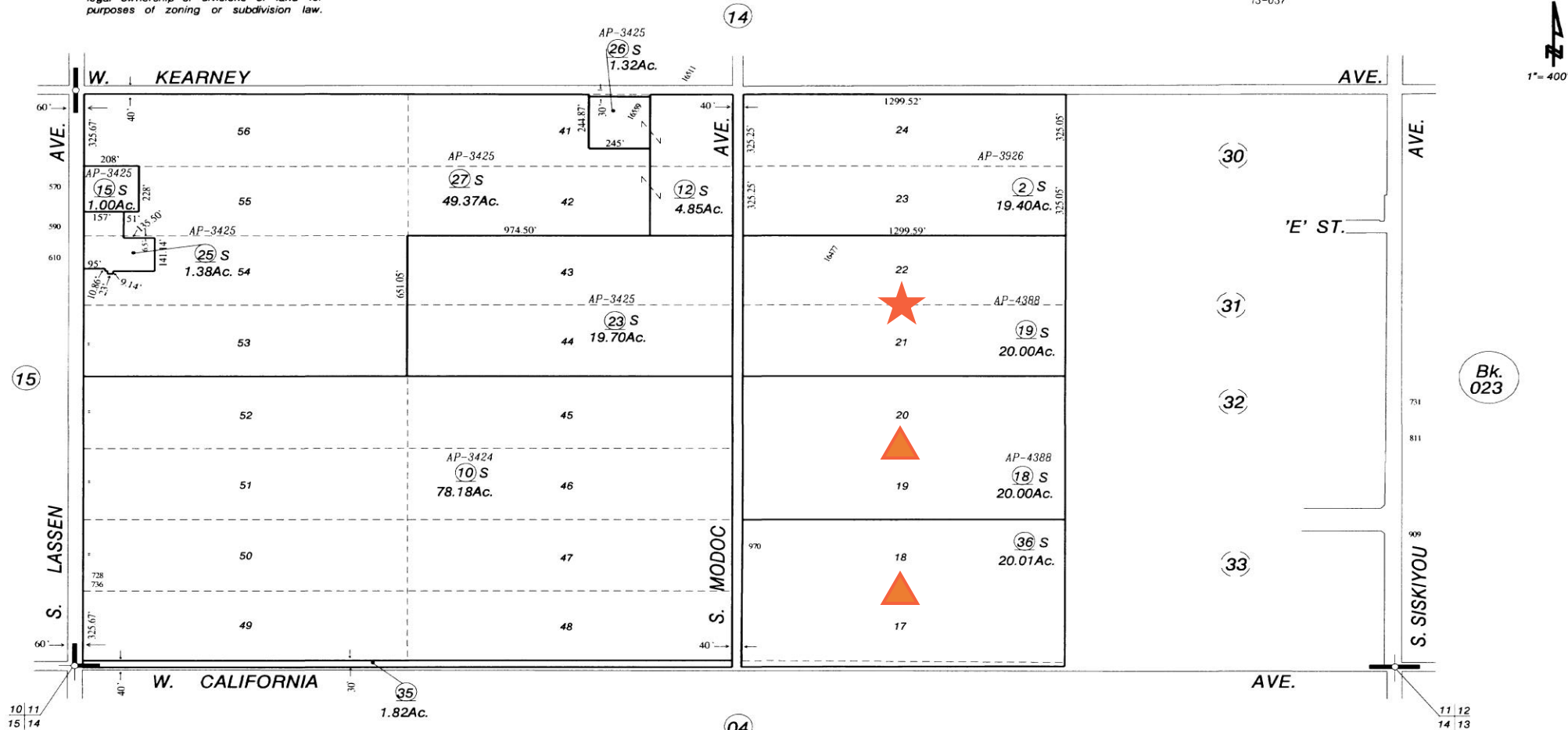

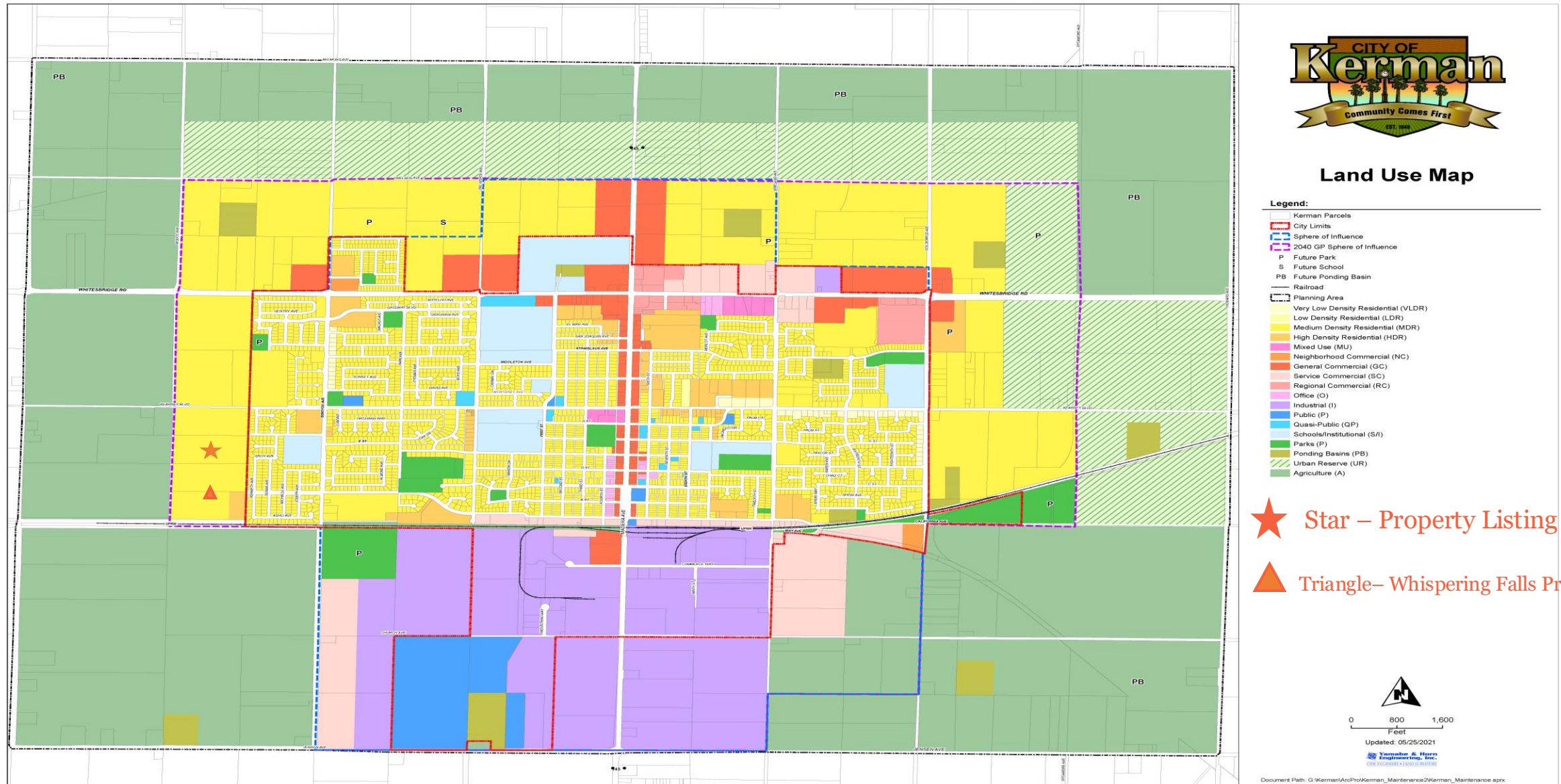

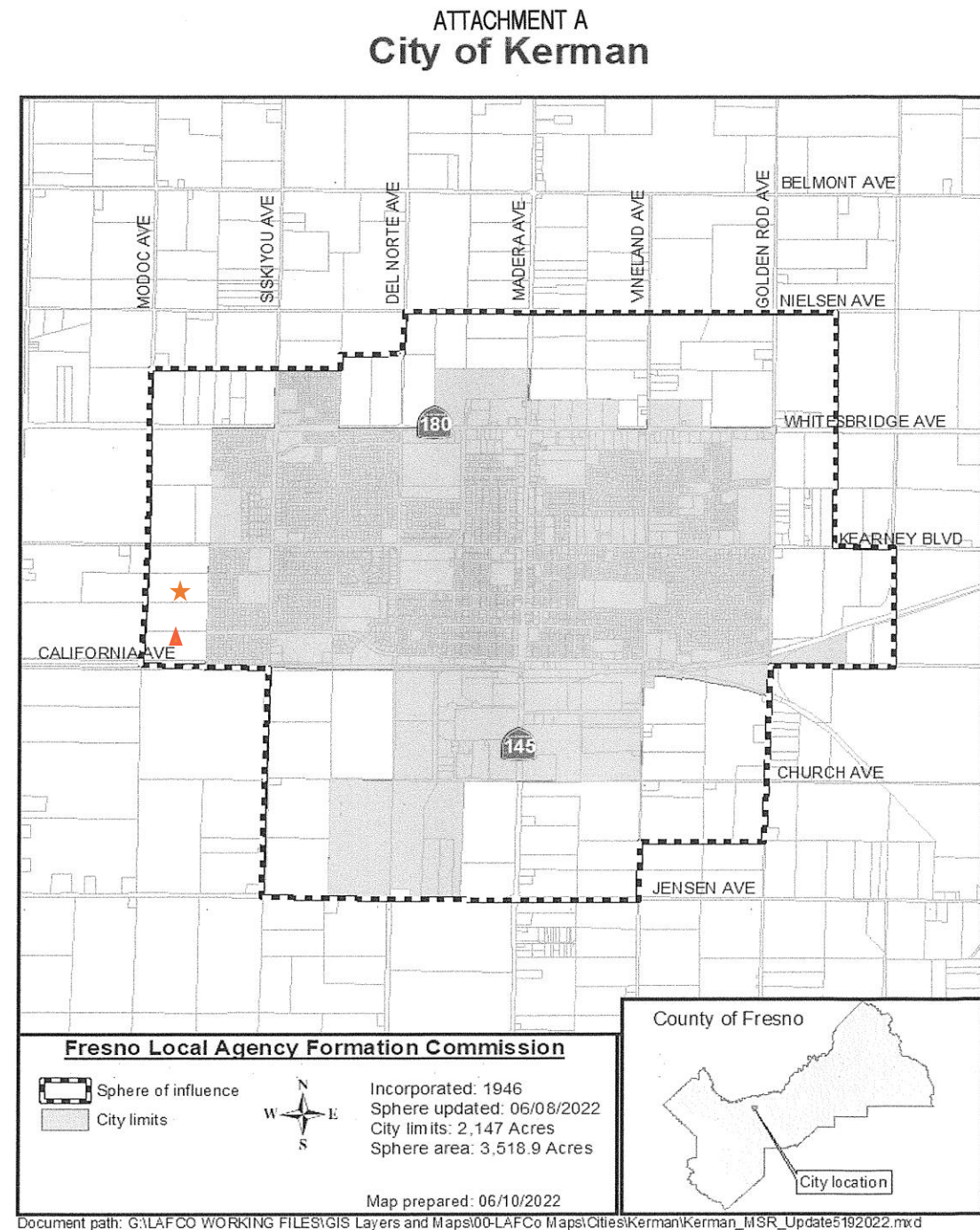

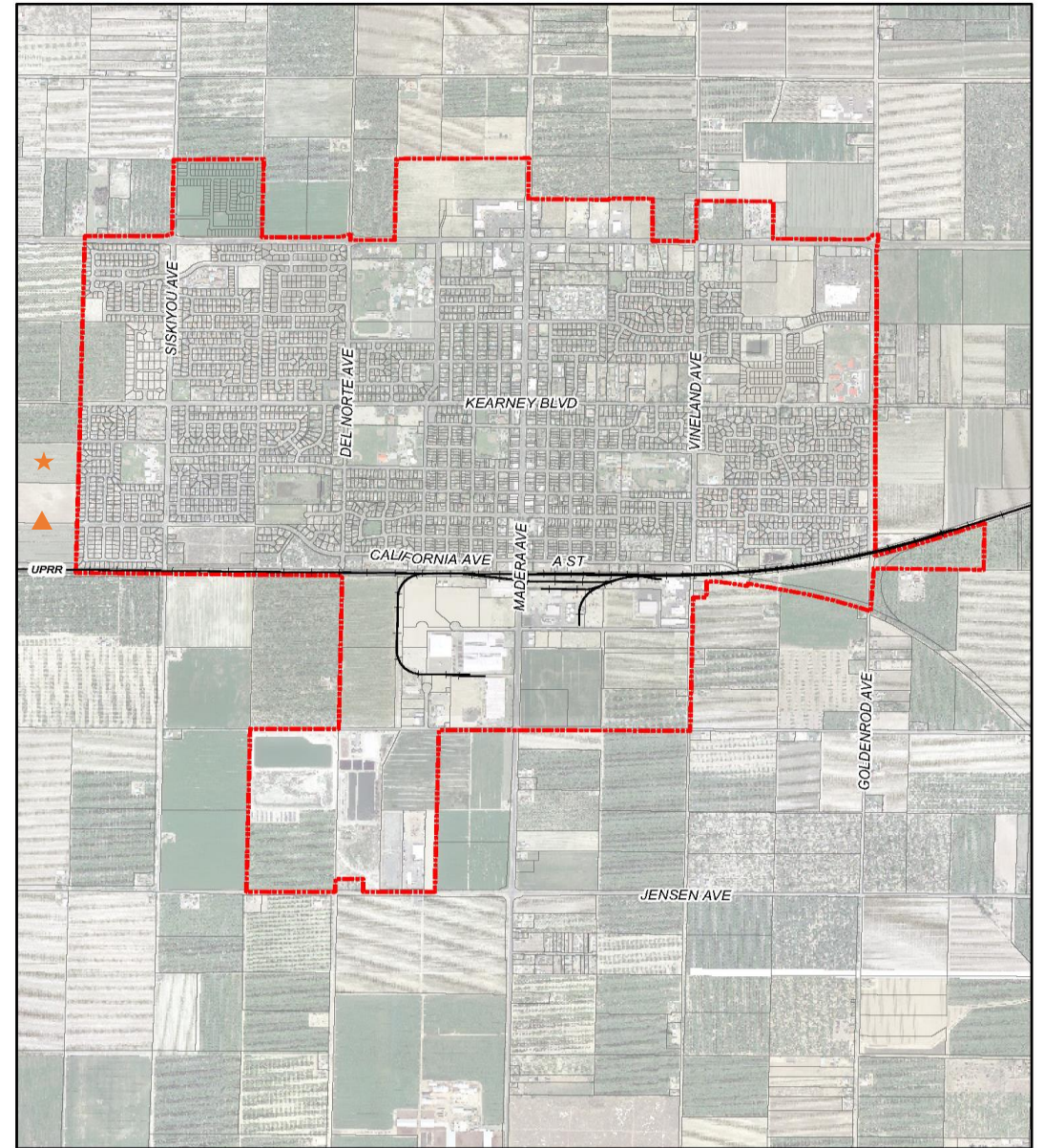




# City of Kerman Map

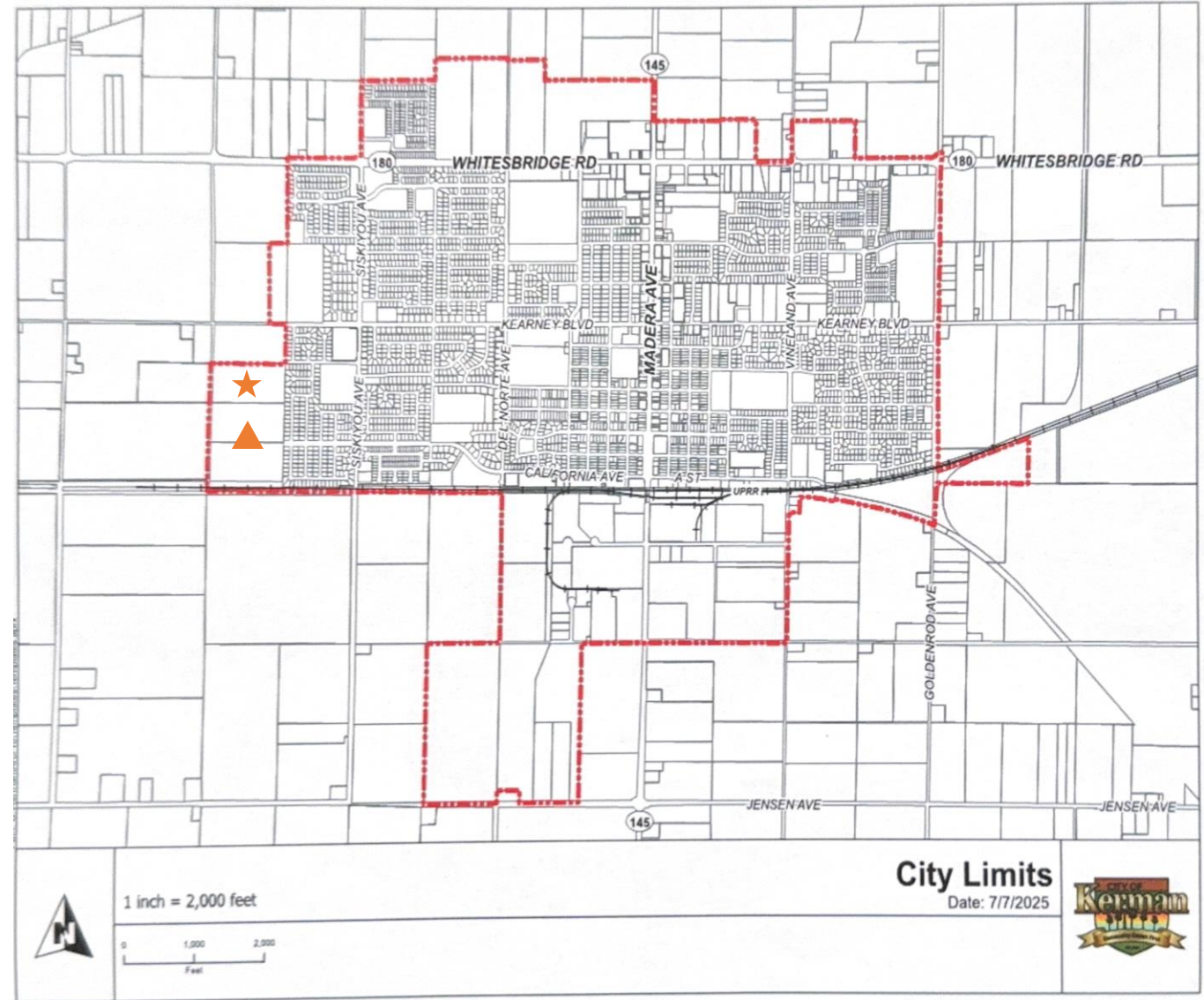

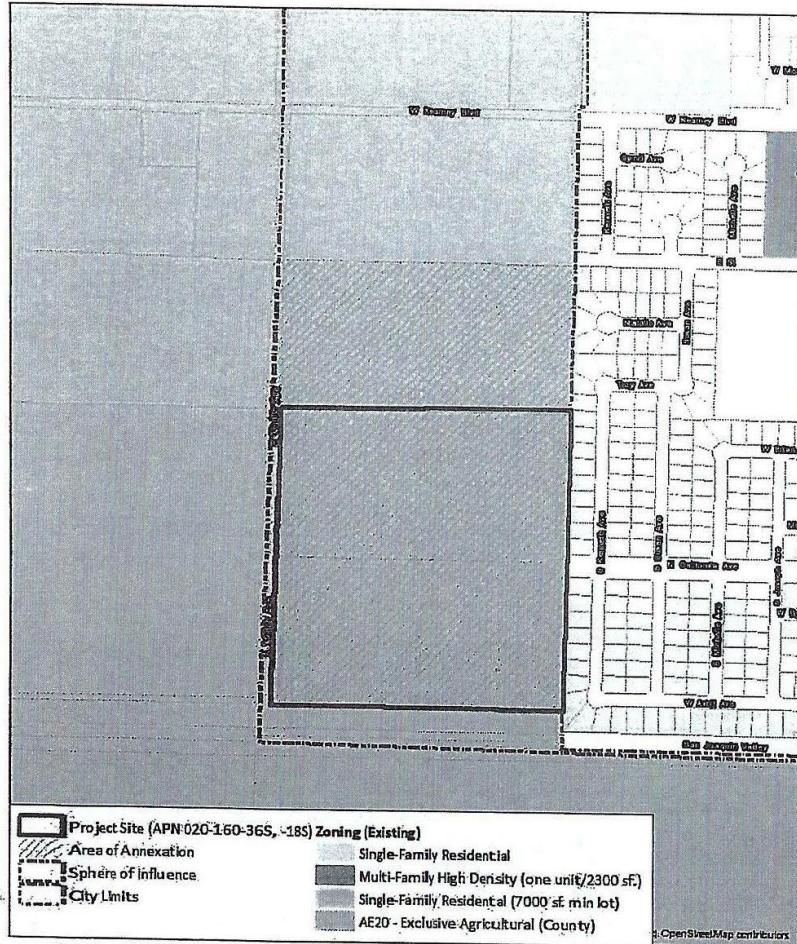

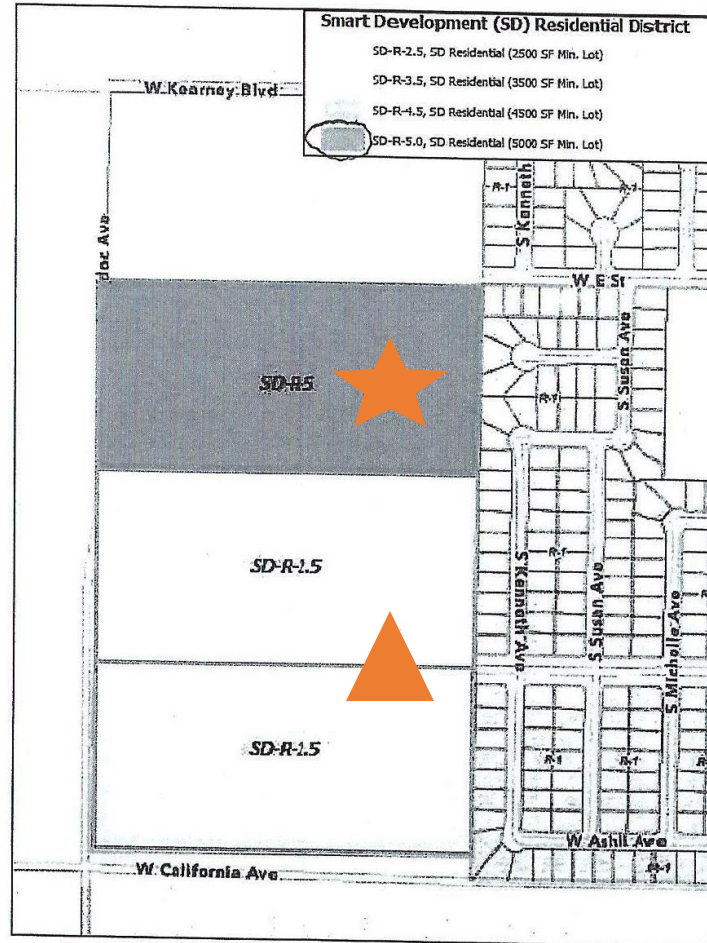

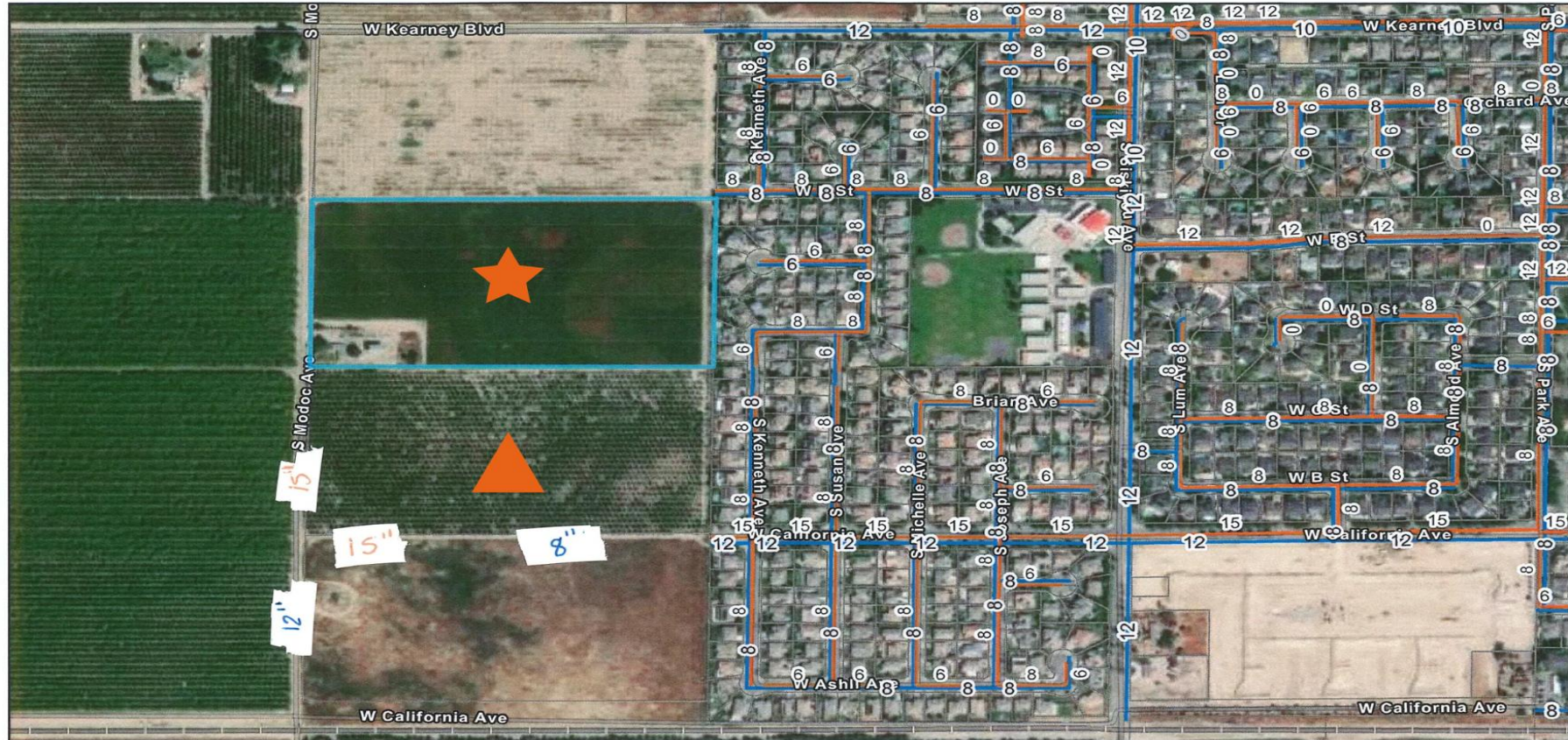

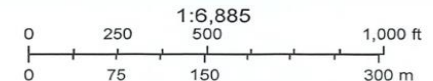
