Not His{story} But the True Story of Overdose Prevention Centers

As you know the first OPCs {Overdose Prevention Centers}, also known as Safe Consumption Sites, in the United States opened in New York City in November of 2021. This documentary explains the process it took to make this possible. It covers the drug war {which is a war on people}, Harm Reduction {keeping people alive until they are ready, if ready}, and stigma against participants and peers. It also includes interviews with elected officials who support OPCs plus advocates who were key to their success such as Cassandra Frederique from Drug Policy Alliance, Hiawatha Collins from Peer Network of New York and folks from other organizations. The documentary focuses on the ten-year fight behind the scenes, and lifts up the contributions of some great harm-reductionists who are sadly no longer with us to see the results of their work.

End Hep C SF - Community Leads the Way

Our most valued asset in the fight to eliminate HCV are the End Hep C SF community members who have been cured themselves and go on to help connect their friends and families to HCV testing and treatment. End Hep C SF honors and thanks these community members, and shares some of their stories and perspectives here.

Everyday People

(A lived experience through Harm Reduction)

Wellness Services is a nonprofit organization located in Flint, Michigan, and has been openly serving the community for over 35 years. Through our community-focused programming and outreach work, Wellness serves as a substantial resource for individuals living with or at risk for HIV, Hepatitis C, and STIs. This client video documentary and discussion will highlight the flow of a client's navigation from enrolling into the SSP to living well and maintaining safer use methods. This video will also document clients' experiences as they live through a pandemic and manage overdose.

Over the Shoulder Used Sharps Holder (30-sec PSA)

Over the Shoulder Used Sharps Holder is a 30-second public service announcement on how to pick-up needles off the street and dispose of them properly, using a handmade sharps container.

Shot in one-take in Skid Row during outreach in Los Angeles, California by award winning Sonya Guerra and sharps safety trainer Joanna Berton Martinez. This PSA is good for front line workers, community members, business owners, and anyone else who might discover a syringe, needle, or broken glass pipe on the ground where they work and/or live.

America's First Supervised Drug Consumption Site

This thirteen-minute documentary follows the first two Overdose Prevention Centers in the United States run and operated by OnPoint NYC. Kailin See, Senior Director of Programs, and Sam Rivera, Executive Director, run through the organization's operations, services, and programming as well as discuss overdose death rates in New York and how the OPCs will impact the drug using community as well as the local community. Additionally, a participant at OnPoint NYC discusses how reusing drug use equipment has negatively affected his health. He reflects on how supervised consumption has changed the way he uses drugs and the positive impact NYC's Overdose Prevention Centers has had on his life.

Recovery is Real

This is the story of young Lisa, a product of the foster care system as well as a child born from two drug addicted parents (which her mother was also a product of the same system).

Mini-Documentary Featuring The Sidewalk Project Outreach by Invisible People

The Sidewalk Project is a lived experience harm reduction organization that works directly on the street with unhoused PWUD, sex workers and people experiencing health and mental health crisis. This documentary shows their mobile SSP doing outreach and explores some of their services centering PWUD and sex workers. They also show their mobile cannabis distribution and speak about the healing benefits for the Skid Row community.

Living On is an experimental video project series that brings together young people who use drugs, researchers, and filmmakers in Vancouver. These short films allow young people to author and illustrate their own stories about drug use, overdose and living through loss, and to move beyond familiar, often stigmatizing, images of addiction in order to develop alternative visual vocabularies for telling these stories. For example, in the first episode, imagined in collaboration with the narrator, images and words are used to evoke the joy and pain of childhood, friendship, drug use and recovery. Idyllic images such as a birthday party were inspired by the narrator's own childhood, as well as more recent experiences of "taking a cake" to mark one year of sobriety in Twelve Step programs.

Piloting Hepatitis C Treatment for Active Drug Users at a Syringe Service Program in Rural Western Massachusetts

Despite advances in modern medicine, multiple barriers to care such as transportation, insurance, and misinformation have prevented many PWUD, a population with a high HCV infection rate, from being treated. While requirements for treatment vary from state to state, the United States has consistently failed to reach the HCV elimination goals projected by the WHO & IOM. Our facility in rural Western Massachusetts, Berkshire Harm Reduction, is piloting a program to treat individuals with HCV who are active drug users, the only clinic in the state to do so. Preliminary results suggest that despite barriers to care, HCV treatment for people who actively use drugs can be effective and retain patient participation. Through incentives and education about the importance of the SVR12s, the program aims to increase the rate of completion and break down the stigmatizations surrounding PWUD. We anticipate our program will be a model for HCV treatment for PWUD in Massachusetts and encourage healthcare providers to offer treatment to patients in active use.

Swallow THIS: A Documentary About Methadone & COVID-19. A screening & talkback with the filmmakers & people interviewed in the film.

COVID-19 changed everything. In this short documentary, *Swallow THIS: A Documentary About Methadone & COVID-19*, we document the impact of the pandemic on people who take methadone. The DEA and SAMHSA eased strict regulations on methadone dispensing and everyone was eligible for 14 or 28 take-home doses. To document this unprecedented reform, we traveled to Connecticut, Massachusetts, New York, North Carolina, and Tennessee to interview patients, clinic staff, drug user activists, and experts. We learned that methadone clinics struggled to protect patients and staff from the coronavirus and the implementation of the new take-home policy was wildly uneven across the country. Some of the people interviewed didn't even know they could get more take-home bottles, but those who did described it as "game changing."
