LEGISLATIVE REPORT— MAY 2023

SB 838 – Proceeds Funding Motorcycle Safety Education Bill—Signed by Governor DeSantis on May 24th, 2023

Bill Description:

An act relating to proceeds funding motorcycle safety education; amending s.320.08, F.S.; requiring that the motorcycle safety education fee be used for a safety and education program administered by Florida not-for-profit corporations; specifying requirements for the administrators of such program; requiring the Department of Highway Safety and Motor Vehicles to enter into certain contracts for a specified purpose; specifying the requirements of the safety awareness and education programs; specifying requirements for certain contracts; requiring the administrator of the programs to file an annual report with the Legislature by a certain date; amending s. 320.086, F.S.; conforming cross-references; requiring the department to select program administrators and enter into specified contracts by a specific date; requiring the department to transmit portions of the safety education fee to the program administrators quarterly; specifying the first payment date; providing an effective date.

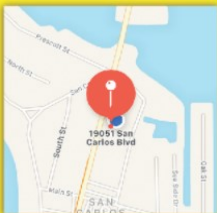

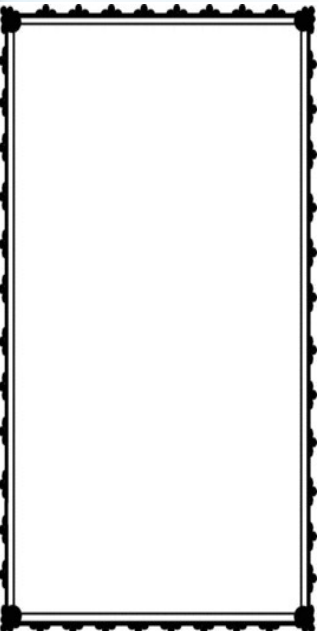
