Deadline

The following applies to all UIL events and UIL sponsored junior high/middle school solo and ensemble events.

- Enter online at www.texasmusicforms.com or with CHARMS by the deadline posted on the Region 13 website event calendar, https://uilregion13.com/home-calendar
- At the entry deadline the entries will become "official" and the total entry fee will be determined based on the "official" entries. Judges will be hired and a budget created based on the official entries. Any deletions after the deadline will not lower the amount due.
 Late entries: As per UIL requirements, the Region 13 REC has enacted the following rule effective
- <u>Late entries</u>: As per UIL requirements, the Region 13 REC has enacted the following rule effective August 1st, 2007 for all UIL and region sponsored solo and ensemble contests: A solo/ensemble entry inadvertently omitted may be submitted after the deadline if it meets the provisions spelled out in the UIL C&CR, section 1108, (g), (1-3) by paying the normal entry fee plus a \$3 late fee per person, per entry.
- <u>Junior high school /middle school solo & ensemble contest:</u> Since the junior high/middle school S&E event is not officially UIL, some rules are flexible. However, to keep the essence of the event the same, please follow the UIL C&CR as closely as possible. Please enter and print all event forms online and write in anomalies as needed.

CONCERT AND SIGHT READING

Required music

 Each band, orchestra, string orchestra and choral group entering the concert evaluation shall conform to the performance requirements listed on the UIL website in effect for the current school year. https://www.uiltexas.org/music/concert-sight-reading

- Those selections so listed on the entry form become program requirements for concert evaluation unless the Executive Secretary is notified, in writing, of changes of selections seven days prior to the first day of the evaluation.
- In the event that an organization does perform without conforming to the program as listed on the entry form after the entry has been certified, that organization and or its director shall be penalized in accordance with Section 27 and 29 of the UIL constitution and contest rules.
