- Provides monthly financials with projections, cash flow and tracks KPIs and analyzes trends.
- Manages investments and audit activities.
- Supervises and backs up the Controller.
- Ensures accurate financial reporting and compliance with regulatory standards, managing financial risks, optimizing cash management, and collaborating with the CEO/Executive Director, sr. leadership, staff and the Board.
- Finance department includes the Fiscal Intermediary Unit (FIU) that provides funds for residents and clients in the money management program.
- Team development and fostering a culture of excellence within the finance department.
