In 1986, a group of AA members decided we were now large enough to have our own District. Also many of the GSR's didn't want to travel to Sacramento every month. So they petitioned CNIA - 07, who approved and District 20 came into being. (Panel 36)

The District proceeded with business, which it has continued including the financing of the Union Newspaper Ad (suspended in 2020), the Hotline Answering Service, the Website ([www.dist20aa.org](http://www.dist20aa.org)), and printed and online meeting schedules. It has hosted several workshops throughout the years for its membership and at least three Area Assemblies, the first on May 18, 1996 being a CNIA Post Conference Assembly held at the Horseman's, a Winter Assembly at St. Canice Hall, Nevada City on January 21, 2006, and most recently the Pre-Conference Assembly on April 19, 2019 held at the Elks Lodge in Nevada City. And another one in 2025.

### **DCM'S (District Committee Member)**

The first District Committee Member (DCM) in 1986 (Panel 36) was Bob V. in 1987 (who often referred to himself as the Mayor of Mooney Flat), who made it clear he would serve for only one year (normal term for a DCM is two years.) Following Bob were Geraldine H. (1987-1988); Hunter (1989-90) (Hunter definitely served in 1989); Marie M. (1991-93) (Marie definitely served in 92-93 and it is thought that she also served in 1991); Linda L. (1994-95); John B. (1996-97); and Mary E. (1998-99). History of Officers can be found on the Addendum 1 Page of this document.

2010 through the present (2025) DCMs were: Mary O. (2010-11); Dan L. (2012-13); Justin P. (2014-15); Kail R. (2016-17); Lisette S. (2018-19); Todd A. (2000-21); Lisette S. (2022-2024); and Eric K. (2024-2025).

## DISTRICT 20

### Meetings

Meetings in District 20 have flourished. In 1980, there were a total of 20 meetings a week in the area which became District 20. In the Fall of 2019, there were a total of 75 meetings. AA remained alive and well in District 20 during the COVID-19 Pandemic: In January 2021, there were a total of 82 regular weekly meetings: 46 online and 36 in person.

We had two Fellowships: The Grass Valley Fellowship, formed in June 1987, and the Gold Country Fellowship, made up of the several meetings which met at the Alano Club, formed in September 1993. Those two Fellowships each have 3-4 meetings each day and have traditionally hosted holiday Alkathons, speaker meetings, potlucks, dances, game nights, campouts and other events. Gold County Fellowship closed when the Northern Mines Alano Club closed in 2021.

### Twelve Step Hotline - Answering Service & The Union Ad History

Prior to the formation of District 20, the two oldest groups in the district, (formed in 1949 and early 1950) the Gold Quartz and Gold Diggers groups, had financed the AA notice in The Union Newspaper and the telephone hotline answering service. Those two services would normally have been handled by Intergroup, but we do not have an Intergroup in Nevada County, and the nearest Central Office is in Sacramento.

With the formation of District 20, the AA group contributions went to help pay for the answering service and The Union newspaper ad which gave out the 24 hour AA hotline number to call which is and has been continuously: 530-272-6287.

For many years, before the District formation and afterwards, the local Al-Anon and Alateen shared the AA hotline and gave donations to the District. The answering service would provide information on both AA and Al-Anon/Alateen meeting schedules. It could be that once Al-Anon started their own Fellowship, they then broke away and got their own hotline. From a District 20 AA meeting schedule dated 1998, Al-Anon and Alateen meetings were still listed in the schedule.

### Standing Committees

The District has a number of Standing Committees to assist with District business, including: Accessibilities, Archives, Bridging the Gap, Grapevine, Literature, PI/CPC, Telephone Answering Service, Meeting Schedules and E-Services. Each of these Committees has a Chairperson responsible for the operation of the Committee. The current Chairs are listed above under Present Officers and Committees. *For more information and for a history of some of these Committees, see Addendum 2.*

## **DISTRICT 20**

### **Website**

The District website started around 2010 by Mike S. who was the first E-Services Chair. Mike served until October 2016. The website address has remained the same since the beginning at [www.dist20aa.org](http://www.dist20aa.org). The website in 2010 consisted of the AA meeting schedule, local events linked to GSO, AA pamphlet of the month link, and the hot-line phone number. Eddy S. became E-Service Chair after Mike's resignation and served through 2017. Ben G. served as E-Services Chair from January to October, 2018, at which time Deb F. took over. Under Deb's management, the website has greatly expanded, taking on a new warming and welcoming look with on-line zoom and in-person meeting schedules, workshop flyers, information about AA, service offices such as Bridging the Gap, Grapevine, PI/CPC, etc. The website also contains documentation from our Archives.

### **DISTRICT EVENTS AND ACTIVITIES.**

#### **Unity Day**

The first Unity Day was held at the Horseman's Lodge in Grass Valley on October 24, 1987. Father Tom W. from Oakland was the main speaker. Some of the members present were: Tom W., Bill S., Pat S., Helen, Bonnie, Vikki, Randy L., Don and Judy R., Sarah S-M., Hunter, Don K., Nancy P-K., Ann H., Nancy K., Rennie S., Marty, Cathy E., Patty N., Pam W-C., Mel W., Clayton G. and his wife, Edna G., Kit W. and her husband, Mike W., Carolyn C., Mary W-M. People were smoking cigarettes at this event.

Thereafter, Unity Days continued annually every February celebrating Valentine's theme of love starting in 1988 and going until 2001 which included a dance with live music except for years 1997 and 1998 where there was a DJ for the dance. All the Valentine Unity Days were held at the Horseman's Lodge except for 1988 to 1992, which were held at the Love Building at Condon Park in Grass Valley. In 2002, Unity Day was moved to September mostly because the weather was better. Unity Day was held thereafter annually in the Fall through 2019. Unity Day 2020 and 2021 was not held due to the COVID-19 Pandemic. *See Addendum 3 for more detail about District Unity Days.*

#### **Old Timers' Celebration.**

In 1998, the District decided to hold an event every two years or so to celebrate our members with 20+ years of sobriety. The first Old Timer's Celebration was October 1998 and held at the Love Building in Condon Park, Grass Valley. Pat S. was the chairperson with help from Beth M. The old timers with more than twenty years that attended were: Juanita, Harry C., Victoria B., Jeri T., Glen (Snuffy) S., Bud T., Clayton G., Mary E., Earle M., Connie N., Dan D., Jolly G., Martha K., Bob V.- D.- L. (Mayor of Mooney Flat), Linda M. (lawn chair Linda), Roger McA. Old-timer Al-Anon's present were Edna G. (Clayton's wife - Edna started Al-Anon in Nevada County), Fae D. (Dan's wife) and Vivian G (Jolly's wife).

Thereafter, there was an Old Timers' Celebration in 2000, 2003, 2007 and 2009. *See Addendum 3 for more detail about the Old Timers' Celebrations.*

### **Other District Events.**

Throughout the years, the District has hosted, in addition to the Area Assemblies discussed above, various Workshops, GSR Schools, Picnics, Campouts, and other events. *See Addendum 3 for more detail about some of these events.*

### **District Guidelines Committee**

In early 2017, at the request of the Men's Wednesday Night Big Book Study Meeting, a District committee was formed to create the District Guidelines. The Guidelines were adopted in September 2017 after many months of intensive work by the Committee and can now be found on our website at [www.dist20aa.org](http://www.dist20aa.org). The committee consisted of Kail R., DCM and Diane R., Alt. DCM, Rodger F., past DCM, Garnet H., Recording Secretary, Lisette S., Treasurer, and two GSRs (Eddy S. and Daemion B.) The Guidelines include job descriptions of the Officers and Committee Chairs, finance info and election and voting procedures, among other things.

**GSR Orientation/School.** Also in 2017, during Panel 68, then ADCM Diane R. began a GSR Orientation and School to help new and continuing GSRs understand their responsibilities and roles. This School, together with Kail and Diane's enthusiasm and guidance during Panel 68, in many members' opinions, revitalized District 20 and gave it a new sense of service and responsibility.

#### STANDING COMMITTEES

The District has a number of Standing Committees to assist with District business, including: Accessibilities, Answering Service, Archives, Bridging the Gap, Coffee/Set-Up, E-Services, Grapevine, Literature, Meeting Schedules, and PI/CPC. Each of these Committees has a Chairperson responsible for the operation of the Committee.

**Accessibilities Committee.** The Accessibilities Committee was established in the District in 2019. The Accessibilities Committee is devoted to helping carry the message of AA to everyone, particularly those isolated because of accessibility issues. Examples of people who may be served by this Committee are:

- People who are hearing or sight impaired;
- Those with transportation issues (military, seniors, limited mobility, homebound, remote, homeless, non-English speakers, low literacy, parents with young children).

The first and current Accessibilities Chairperson is Eric K.

**Answering Service.** The Answering Service Committee is one of the original committees of the District; in fact, this Committee existed prior to formation of the District. Prior to the formation of the District in 1986, the Answering Service (also known as the Hot Line) was financed and managed by the two oldest groups in the District, the Gold Quartz and Gold Diggers meetings. This Committee is charged with maintaining the answering service for the District, the primary purpose of which is to be sure that anyone seeking help with their problems with alcohol is directed to appropriate meetings and AA members. The Chairperson of this committee is responsible for creating a list of volunteers willing and able to answer calls, preparing monthly call reports, and coordinating with the telephone answering service engaged by the District. One of the first Chairpersons of this Committee was Jerral S. in 1989. Other Chairs have been Mary E., Sarah S-M, Chuck S., Tex T., Henry C., Yvonne Q-B., Kathie T., Ann R., and Steve K.

**Archives.** The Archives Committee is also one of the original committees of the District. This Committee is responsible for collecting, organizing, and displaying items from the District's history that are of importance or interest to the local AA groups. This would include group histories in the District, minutes from District meetings, flyers for special events and information about the beginning of AA in our area and the beginnings of groups in District 20. One of the first Archive Chairs was Harry C. in 1989. Other Archive Chairs have been Bob V., Jim B., Mark G., Cheryl N., Martha K., Steve K., Sean O. and Rita B.

**Bridging the Gap (BTG).** BTG is responsible for coordinating the transition of residents and inmates of recovery homes, jails and other institutions to the AA community. BTG collaborates and coordinates with each of those institution and works closely with the area Hospitals and Institutions Committee (H&I). It is believed that BTG started in the District around 1995 and

that Linda L. was the first BTG chair; however, the first mention of BTG found in the Archives was in 2012. The Chairperson that year was John C. Other BTG chairs have been Pamela M., Lucinda P., and Amy M.

**Coffee/Set UP.** The first time the District had official Coffee and Set up people was Panel 68 in 2018-2019. Prior to that, volunteers took care of making the coffee and providing supplies for the District meetings. The first Coffee/Set Up committee was Diane and Ray from the Sierra Pines meetings in Lake of the Pines. The next committee chair was Krista.

**E-Services.** With the advent of the internet and on-line services came the necessity of setting up and maintaining a website for the District. The District website ([www.dist20aa.org](http://www.dist20aa.org)) was set up by Mike S., who was the first E-Services Chair. Other E-Services Chairs have been Eddy S., Ben G., and Deb F. See *Website* in foregoing document.

**June 24,2023** District meeting: It was decided for all District 20 GSR meetings to be Hybrid. The on-line account number and passcode will be displayed on District 20 Agendas or AA member can text DCM for the current information. The member to set up the Hybrid meeting would preferably be handled by the E-Services Chairperson.

**Grapevine.** The Grapevine Chair is responsible for informing the District about all matters concerning the *Grapevine* and *LaVina*. The Grapevine Chair subscribes to the Grapevine, develops Grapevine writing workshops and otherwise coordinates activities between the District and AA Grapevine.org. The Grapevine Chair in 1993 was Rennie S. Other Grapevine Chairs have been Jan P., Denise R., Jim C., Mick M., Katrina, Ed H., Jessica J., and Beth C.

**Literature.** The Literature Committee acts as a resource for the District with information and assistance regarding AA literature. The Literature Chair is responsible for keeping abreast of all AA literature, encourages the purchase of AA Conference approved literature and is a resource to individual meetings for the acquisition of AA literature. The District has had a Literature Chair since at least 1998, when the Chair was Ann. Other Chairs have been Ray, Karen S., Cynthia W., and Rebecca J.

**Meeting Schedules.** The Meeting Schedules Chair is responsible for keeping the printed meeting schedules accurate and up to date by communicating with District groups to ascertain meeting locations, dates, times and accessibility. He/she updates the meeting schedule as needed to maintain accuracy and works with the e-services chair to maintain and link online schedule to the District website. Bruce J., a long-time AA District member, was responsible for updating and maintaining the meeting schedules for at least 20 years (1992 - 2012) and perhaps longer. Once Bruce stopped doing it, some of the Meeting Schedule Chairs have been Jeff H., Ben G., and Susan A.

### **Public Information Committee**

PI/CPC Committee (Public Information and Cooperation with the Professional Community) provides information about AA to members of the community whose profession may bring them in regular contact with anyone who may suffer from the disease of alcoholism. It offers

information through a variety of methods and seeks to establish simple and effective ways to work with professionals with a policy of "cooperation, but not affiliation." PI/CPC informs professionals and the public about AA - what we are, where we are, what we can do, and what we cannot do, through use of GSO and district websites, wide range of pamphlets, district meeting schedules, presentations and PSAs.

The District's PI/CPC Committee was formed in 1991 and ran until 1998 with Sarah S-M. as the chair person. First meeting was held on February 5, 1991. In attendance were: Sarah S-M., Marcia K., Dan N., Hunter, Alan D., Mary E. and Ken B. The committee met once a month and had different members. Each month, education of what the team was about, was a priority. The team put together mailings for the clergy, doctors and general agencies. Provided Big Books to public and school libraries, Senior Center, etc. Provided packets of literature to the emergency room in the local hospital. In 1996, the team worked on changing the wording for the newspaper advertisement and got the AA groups involved. In the end, no change was made except to add the District website's address. Some of the ideas for changing the ad were used to create Public Service Announcements for the radio. The committee provided an information booth at the Penn Valley Rotary Club on July 20, 1996 and manned a booth at the Health and Safety Fair on October 5, 1996.

More recently, Connie S. as PI/CPC chairperson with committee: Lucinda P., Mary O., Lisette S. and Brenda B. and has been very active in having presence at Nevada County Stand Down's, Granite Wellness Recovery Fest, did a presentation with Hospice staff, taken pamphlets to B.H. Urgent Care and Wayne Brown Jail and made sure libraries has Big Books. Other PI/CPC Chairs throughout the years have been George S., Greg P., and Mary O. The most current PI/CPC chairperson, past DCM Lisette S., is actively involved, with her committee, in discovering and creating new and innovative ways to carry the message to the professional community in the District.

## OTHER DISTRICT EVENTS

Throughout the years, the District has sponsored many workshops and other educational events for its members, often including Area officers, delegates and chairpersons in panels and as speakers and/or coordinators. We do not have sufficient detail in our Archives at this time to discuss most of these. The following are just a few of these events:

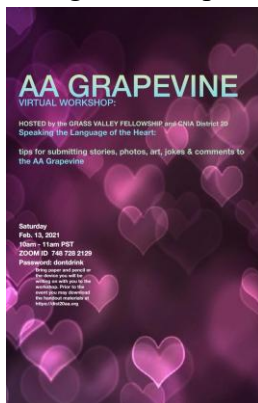
On May 20, 1989 the District put on a **Twelve Step Workshop** with Sarah S-M. and Hunter as chairpersons. Jerral S. was the Answering Service hotline chairperson at the time. This event took place at the Grass Valley Fellowship at 714 W. Main Street. A humorous impromptu skit was performed by Henry M. (Play & TV Writer - Deceased), as the drunk and Jerral S., as the AA member. The skit went something like this: Henry thought he was calling triple A. He told Jerral he wanted his wife and kids back. Jerral at the end of the conversation was able to persuade Henry to allow two members of AA to come visit him and possibly take him to a meeting. At this same workshop, Harry C. with 29 years of sobriety related a funny story of how Clayton G. Twelve Stepped him in jail. Also speaking at this workshop was Clayton G., Henry M. and George S., and Evert from Teleservices in Sacramento. A list of volunteers for the answering service hotline was created from the workshop and a list of people willing to go out on twelve step calls to caller's homes was created also. Archives has an audio cassette tape of this event and hopes to get it transferred onto a CD so copies can be made.



On November 25, 1990, the District obtained the **Delegate to New York**, Fred B. to speak to our District members at the Grass Valley Fellowship at 714 W. Main Street, Grass Valley.

District 20 and 21 put on **GSR School** on May 24, 1997 held at Peace Lutheran Church in Grass Valley, featuring Inez Y., Area Officer.

On January 20, 2021, District 20 participated in one of the first CNIA Unity zoom meetings. Sarah M. spoke about the history of District 20. Then three District members in District service shared their experience, strength and hope.
