## **RESOLUTION 2026-02**

### **A RESOLUTION CONCERNING CANCELLATION OF THE MUNICIPAL ELECTION TO BE HELD ON TUESDAY, APRIL 7, 2026 AND DECLARATION OF CANDIDATES ELECTED**

**WHEREAS**, the regular municipal election for the Town of Silver Plume was to be held on Tuesday, April 7, 2026, for the purpose of electing six Trustees and a Mayor; and

**WHEREAS**, pursuant to C.R.S. 31-10-507 and Town of Silver Plume Ordinance 343, said election may be cancelled if the only matter before the voters is the election of persons to office, and if, at the close of business on the sixty-fourth day before the election, there are not more candidates than offices to be filled at such election, including candidates filing affidavits of intent; and

**WHEREAS**, at the close of business on the sixty-fourth day before the election; not more candidates than offices to be filled at said election, including candidates filing affidavits of intent, were filed, and

**WHEREAS**, the Board of Trustees of the Town of Silver Plume wishes to authorize the Town Clerk to cancel the April 7, 2026 election as such circumstances are present.

### **NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF SILVER PLUME COLORADO:**

**Section 1.** Pursuant to Ordinance 343 and C.R.S. 31-10-507, the Board of Trustees hereby authorizes and instructs the Town Clerk to cancel the April 7, 2026 Town election as the only matter before the voters is the election of persons to office, and as, at the close of business on the sixty-fourth day before the election, there were not more candidates than offices to be filled at said election, including candidates filing affidavits of intent.

**Section 2.** Pursuant to Ordinance 343 and C.R.S. 31-10-507, the Board of Trustees hereby declares elected to the Silver Plume Board of Trustees:  
Leonard Berenato elected as Mayor for a two-year term and;  
Martin Gitlin,  
R. "Mac" McDonald,  
Michael Frey,  
Mark Basham,  
and  
Cory Chylik  
elected as Trustees each for a two-year term, such terms to commence upon being sworn into office at the first regular April meeting of the Board of Trustees on April 13, 2026.


**Section 3.** Effective date: This Resolution shall be effective upon passage.
