AN AMENDED RESOLUTION OF THE TOWN OF SILVER PLUME BOARD OF TRUSTEES AMENDING RESOLUTION NO. 2023-03 CONCERNING REVISED HOURS OF THE TOWN HALL OF THE TOWN OF SILVER PLUME, COLORADO

WHEREAS, the Town of Silver Plume, Colorado (the "Town") is a home rule municipality duly and regularly organized and now validly existing as a body corporate and politic under and by virtue of the Constitution and laws of the State of Colorado; and

WHEREAS, the Town Board of Trustees adopted Resolution 2023-03 on March 27, 2023, which set forth revised hours for the Town Hall located at 710 Main Street, Silver Plume, Colorado; and

WHEREAS, the Town Board of Trustees has determined that it is not feasible to maintain the revised hours in Town Hall as set forth in Resolution NO. 2023-03 due to current and temporary staffing changes in Town Hall, which necessitate a revised temporary schedule for the hours during which Town Hall shall be open to the public; and

WHEREAS, the Town Board of Trustees hereby finds that establishing revised hours for the Town Hall is in the best interests of the Town; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF SILVER PLUME, COLORADO, THAT:

1. Commencing on April 10, 2023, the Town Hall of the Town of Silver Plume, Colorado, located at 710 Main Street, Silver Plume, Colorado, shall be open to the public during the week as follows:

Monday through Thursday: 1:00 p.m. to 5:00 p.m.

Town Hall shall be closed to the public on Friday, Saturday, and Sunday of each week; and

2. The physical presence of the temporary Town Clerk or such other staff as specifically designated by the Personnel Management Committee shall be required in Town Hall during the hours set forth in paragraph 1 above, with the exception of authorized breaks as allowed under Colorado law, or necessary errands and duties on behalf of the Town as authorized by the Personnel Management Committee; and
3. For authorized physical absences from the Town Hall during regular hours set forth above, appropriate signage shall be posted on the front door of the Town Hall to provide notice when Town Hall shall be reopened. Absences and closures due to emergencies or weather related circumstances shall also be posted as soon as possible on the website of the Town of Silver Plume at www.silverplumetown.com; and
4. The revised hours of the Town Hall shall be updated and posted as soon as feasible on the Town's website and posted on the front door of Town Hall, and such revised hours shall continue until further notice.
