This meet will be conducted under the auspices of Southeastern Swimming, Inc. of USA Swimming. USA Swimming technical rules and regulations will be followed with the exception of items specifically addressed in the meet information Sanctioned by Southeastern Swimming, Inc.

**HOSTED BY:** Huntsville Swim Association, P.O. Box 1102, Huntsville, AL 35807, (256)270-9255

**LOCATION:** Huntsville Aquatics Center, Huntsville, AL 35805

**FACILITIES:** The meet will be run in the 10 lane x 25 yard course for prelims and finals, with a 7 foot consistent depth, non-turbulent lane lines, and fully automatic Colorado electronic timing system with full video display. Wi-Fi is available throughout the building. A live stream of the event will be made available via the HSA Live Stream channel on YouTube. All monetary transactions at HSA hosted meets are now cashless.

The competition course has not been certified in accordance with 104.2.2C(4).

Use of audiovisual recording devices, including a cell phone, is not permitted in changing areas, restrooms, behind the starting blocks, or locker rooms.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Drones are not allowed.

No flash photography.

Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy (“MAAPP”), will govern this meet.

The swimmer must wear only one swimsuit in one of two pieces, except as provided in 205.10.1. All male swimsuits shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee. No technical suits shall be worn by any 12 and Under USA Swimming athlete member in competition at any sanctioned, approved, or observed meet. Note - 102.8.F

**PARKING:** Parking is available in the front of the facility, as well as in the large lot just over the bridge in the back of the facility. Any car not parked in a marked space, or parked in the adjacent business’s parking lots are subject to being towed. Additional overflow parking is available across Drake Ave. in the public park.

**RULES:** Current USA Swimming rules will govern the conduct of the meet unless otherwise noted herein.

**SWIMMERS:**

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.

**ELIGIBILITY:**

All participants must be USA Swimming registered athletes. Entries will not be accepted without CURRENT registration numbers. Coaches and officials must present evidence of certification as required by Southeastern Swimming. A swimmer's age on the first day of the meet will determine his or her age for the entire meet. On deck registration will not be permitted.

**WARM UP:**

Southeastern Swimming Meet Safety Guidelines and Warm-up Procedures will be in effect at this meet. The Meet Director will post and announce the warm-up assignments prior to the start of the meet warm-up. Swimmers attending the meet without a coach must report to the Meet Director or Referee to be assigned a coach for warm-up prior to each session. A Swimmer Assignment Form will be completed for all swimmers without coaches.

**ENTRIES:**

Swimmers are limited to two (2) individual events on Friday PM, and three (3) individual events each on Saturday and Sunday.

See attached list of events. All events are Short Course Yards.

Entries will be limited to 400 visiting swimmers.

Entry error: if due to an HSA error, the swimmer will be deck entered in an open lane of the heat nearest his/ her entry time or in a new heat. The entire event will not be re-seeded.

Only e-mailed HYTEK entries will be accepted.

**DISABILITIES:**

Swimmers with disabilities are welcome and must complete the Information Form for Disabled Swimmers and return it with the entries.

**DEADLINE:**

Entry e-mails are due by Tuesday, January 2nd, at 11:59 pm. Waivers, and entry fees, including all meet fees and surcharges, must be received at the team check-in office on Friday, January 12<sup>th</sup>, 2024.

Late entries will be accepted on a lane available basis until the start of each session.

**FEES:** \$8.00 per individual event, \$4.00 per swimmer SES surcharge, and \$20.00 per swimmer Facility Fee.

Late entries will be accepted at the discretion of the meet directors on a “lane available” basis. Late entries will be charged \$10.00 per individual event and in addition to the surcharge and Facility Fee if swimmer not already entered in meet. All entry fees are nonrefundable.

Waivers and entry fees, including all meet fees and surcharges, should be mailed presented at the time of check-in on the first day of the meet in the Team Check-in room.

**MEET FORMAT:**

This is a prelim/finals meet for all 10 & Under, 11-12, 13-14, and Open events on Saturday and Sunday 200 yards and below, and timed final for all Friday night events, as well as the 13-14 and Open 500 Free on Sunday. All Finals sessions will consist of a 10 & Under A Final, 11-12 A Final, a 13-14 A and B Final, and an Open A, B, and C Final. All events will be pre-seeded except the 500 Free, 1650 Free, and 400 IM, which will be deck-seeded. Swimmers must sign-in with the Clerk of Course for all deck-seeded events. Friday night Sign-in deadlines are 30 minutes before the start of the session in which the event occurs. Saturday and Sunday Sign-in deadlines are the start of the session in which the event occurs. If the swimmer is not checked in with the Clerk of Course, the swimmer is legally scratched from the event. Only the swimmer or his/her coach may sign in for deck-seeded events. HSA reserves the right to limit the number of heats in deck-seeded events in order to run the meet in the allotted time. HSA reserves the right to run the meet in the best configuration of the 18 lanes that it sees fit.

Events 3, 4, 5, 6, 7, 8, 89, 90 (400IM, 500 Free, 1650 Free) will be seeded fastest to slowest, alternating female and male heats. Results will be posted separately by age-group. Failure to swim a deck seeded event after signing in may result in the swimmer being barred from swimming his/her next individual event. Only the swimmer or his/her coach may sign in for deck-seeded events.

**AWARDS:** 1<sup>st</sup> through 8<sup>th</sup> place ribbons will be given for all 10 & under events. Ribbons can be picked up at the conclusion of the meet in the team check-in room. No awards will be given for 11 & over events.

**SCORING:** Scoring will be for 1<sup>st</sup>-20<sup>th</sup> place, and will be scored 24-21-20-19-18-17-16-15-14-13-11-9-8-7-6-5-4-3-2-1.

**TIME TRIALS:**

Individual time trials will be offered at the discretion of the meet referee, and dependent on the overall timeline of the meet. Cost will be \$10.00 per event. No relay time trials will be offered.

**COACHES' CORNER:**

Coaches' Meeting will occur only if needed at 8:20 am on Saturday, January 13<sup>th</sup>, 2024.

Real time results will be available on the Meet Mobile App.

SES rules dictate, “Coaches shall display, when requested, their USAS Membership card/deck pass to be allowed on deck. Compliance shall be the responsibility of the Host Meet Referee/director - they may assign the responsibility to other meet personnel. All coaches are required to be prepared to display their valid USAS Membership card/deck pass when checking in with Clerk of Course or Meet Director at the beginning of the meet to show proof of membership and standing.

Any deck officials interested in working the meet should contact the meet referee. Any AO officials interested in working the meet should contact the Administrative Official. Training and officials' meetings will be offered and announced at a later time.
