Directive CCC 2020-3  
Participation in Peaceful Protests, Marches or Assemblies

To: Worshipful Masters, Wardens, Past Masters and Brethren of all Subordinate Lodges of the Most Worshipful Prince Hall Grand Lodge of Ohio, Free and Accepted Masons

Greetings:

On Sunday May 31, 2020 I issued a statement from my Office regarding the horrific and senseless killing of George Floyd at the hands of Law Enforcement in Minneapolis, Minnesota. Since then, a number of questions have been raised regarding if and how our members may participate in peaceful protests, marches or other assemblies that are designed to honor the Floyd Family and bring forth meaningful change in policing practices and address the social Pandemic of systemic racism existing in communities throughout Ohio.

Brothers are permitted to participate in such activity as a Lodge, combined Lodges, or District-wide, provided the following are met:

1. The Worshipful Master(s) of the participating Lodge(s) and the RW Deputy Grand Lecturer of the affected District must be notified and approve of the activity.
2. The RW Deputy Grand Lecturer, after consultation with the MW Grand Master, will coordinate the logistics of the Lodge(s) participation.
3. Masonic Polo Shirts, hats, or other such paraphernalia may be worn. However, the preferred dress is Masonic Dress (Black Suit, White Shirt, Black tie, Black shoes and sox) in order that we may be uniform in both purpose and appearance.
4. Participation must be **PEACEFUL, with proper dignity and decorum being displayed at all times**. Any conduct that is derogatory or inconsistent with the tenets of our Order will subject the offending member to appropriate disciplinary action. At all times remember who you represent.
