

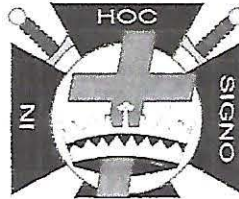

## DIRECTIVE BTJ 2020-003

By the power vested in me as the Right Eminent Grand Commander of the Prince Hall Grand Commandery of Knights Templar of Ohio and Jurisdiction, I do hereby waive all Constitutional regulations pertaining to enrolling new members and Direct open Enrollment for the local Guilds of Heroines of Templar Crusades owing allegiance to the David V. Moore Grand Guild of Ohio and Jurisdiction. The Open Enrollment is for those female OES members in good standing with their Eastern Star Chapter and have a desire to join the local Guild of HOTC and have no male bloodline connection to a member of the local Knights Templar Commandery. This Open Enrollment period will begin immediately and will end on July 31, 2020. This open enrollment should only accept those Eastern Star members that will conform to the precepts and rules of a Guild of Heroines of Templar Crusades and will bring honor to themselves and their Guild. Only those petitions received before the deadline of July 31, 2020 will be accepted.
