PROPOSED RESOLUTION

The following resolution is proposed for consideration by the craft pursuant to the provisions of Chapter 15, Section 15.08 of the Grand Lodge By-Laws.

Whereas, During the administration of MWPGM Kelvin J. Davis differences in how the first three degrees (EA, FC, and MM) are conferred were resolved through a detailed and comprehensive review and analysis of each degree; and

Whereas, Directive CCC 2020-7 outlines the specific areas of clarification for each degree resulting from the detailed review and analysis; and

Whereas, In order to promote consistency and uniformity , it is imperative that these areas of clarification and others that may be subsequently adopted by the craft be made a permanent part of the Official Ritual of the MWPHGL of Ohio; and

Whereas, the creation of a supplement to the existing Ritual would be the most efficient and cost effective way to incorporate these areas of clarification.

Therefore, be it Resolved that the MWPHGL of Ohio hereby adopts the use of a supplement to the existing Ritual and that the clarifications outlined in
