Review: Goal of Vision Screening

- Identify children with potential vision problems.
- Provide notification to parents and others.
- Referral for additional evaluation, treatment, and follow-up services.
- Ensure children with vision problems receive appropriate eye care and vision is corrected to fullest potential.
- Understand that all children have the capacity to learn, grow and develop.

Vision Screening Forms

- Class lists (if in an educational setting)
- Vision Screening Record Form
- Referral Form
- · Vision Follow-up Record
- Individual results should be placed in student's record
- Develop a time-line for follow-up



Notification/Referrals

- Parents and guardians should be notified of an abnormal screening within two weeks of vision screening / rescreening.
- All referrals are made to the parent/guardian for follow-up with one of the following:
 - Ophthalmologist
 - Optometrist
 - Physician
 - Primary care provider



Communication with Parents/Guardians

- Parents want you to appreciate their concern for their child's health.
- Parents want clear and accurate information.
- Parents want you to recognize that they want the best for their child.
- Parents need to be met at their level.
