This is not a debt consolidation or bill payment program. Federal law requires that any unverifiable, outdated or erroneous information must be removed from consumer credit reports by reporting agencies. Hudson Trust, LLC agrees to use its best efforts to provide the Services, and will perform them in accordance with federal and state laws.
- B. The best way to ensure that the credit reporting agencies will respond and a great way to enforce the 30-day law under the Fair Credit Reporting Act is via Certified Mail. We will send everything out Certified Mail to credit bureaus.
- C. The Client(s) agrees to indemnify and hold Hudson Trust, LLC, their agents, brokers and independent contractors harmless from all losses, expenses, fees including attorney fees, cost, judgments that may be asserted against the Client(s) that result from acts of omissions.
- D. All claims and disputes arising under or relating to this Agreement must be settled by binding arbitration in South Carolina. Any award of arbitration may be confirmed in a court of competent jurisdiction.
