What information we collect, use, and why

We collect or use the following information to **provide services and goods, including delivery**:

- Names and contact details
- Website user information (including user journeys and cookie tracking)
- Records of meetings and decisions

We collect or use the following information for **service updates or marketing purposes**:

- Names and contact details

We collect or use the following information for **research or archiving purposes**:

- Names and contact details

We collect or use the following information to **comply with legal requirements**:

- Name
- Identification documents

We collect or use the following personal information for **dealing with queries, complaints or claims**:

- Names and contact details
- Customer or client accounts and records

Lawful bases and data protection rights

Under UK data protection law, we must have a “lawful basis” for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO’s website.

Which lawful basis we rely on may affect your data protection rights which are in brief set out below. You can find out more about your data protection rights and the exemptions which may apply on the ICO’s website:

- **Your right of access** - You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. How long we keep information

- Up to 3 years where no requirement for retention exists with a regulatory body.
- Indefinitely where legitimate to do so in order to comply with the requirements of a regulatory body.

Who we share information with

Others we share personal information with

- The employer of the individual
- Contractors or sub-contractors of your employer where it forms a part of contracted services
- Organisations in the interest of safeguarding
- Organisations or bodies in the interest of national security
- Relevant regulatory authorities
- External auditors or inspectors

Sharing information outside the UK

Where necessary, we may transfer personal information outside of the UK. When doing so, we comply with the UK GDPR, making sure appropriate safeguards are in place.
