

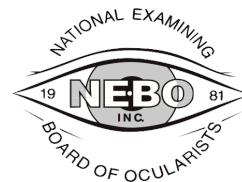

### **The National Registry**

The National Registry for Certified Ocularists is an alphabetical and geographical listing of all currently Board Certified Ocularists in the United States, Argentina, Belgium, Canada, India and Venezuela. This list includes individuals who have qualified to sit for the examination by having completed the necessary education and/or training and experience requirements and having completed these preliminary requirements, have further demonstrated (voluntarily) a competence in the fitting and fabrication of ophthalmic prosthetics by satisfactory completion of the National Examining Board of Ocularists certification and recertification requirements.

Once Board Certification has been achieved, the National Examining Board requires a specific number of continuing education credits in the eye health care related field and ocularistry. These CE credits are compulsory for recertification every 4 years. Although certification was a voluntary action taken by the entrants of this registry, this added measure of continuing education credits assures their intent to abide by the standards set by NEBO.

It is the intent to provide a national standard that can be used as a measure of professionalism by interested agencies, groups, and individuals. The responsibility for professional integrity and excellence remains with the ocularist.



Please note the change in certification numbers. B.C.O.'s that have completed their recertification/registration requirement in 2019/2020 have been transitioned to the new scheme for recertification. A 4-calendar year cycle requiring 200 CE credits to prove continued competency. The Certificate number for these B.C.O.'s will not change (First set of digits is the year the certification exam was taken- ID Number, Ex: 19-345). B.C.O.'s that have expiration dates in the next 2 years will transition to the new system once they complete their next requirement. The Certificate numbers for these B.C.O.'s, in addition to the first two sets of digits has a third digit that establishes the year the B.C.O. must recertify. Ex. 12-345-20. 


