We are pleased to announce that applications to the 2024, 208 Tattoo Festival are now being accepted.

The booth price this year is \$700 per single (10x10) / \$1400 per double (10x20), which includes pipe and drape, tables, chairs, electric, sharps container/ disposal and three (3) passes for the show. A maximum of two (2) artists may work at any one time in a 10x10 booth..

To reserve your booth for the **208 Tattoo Festival**, complete the contract and return by email to info@208tattoofest.com. An invoice will be sent for payment. – Money order, or major credit cards are acceptable forms of payment. If you prefer to pay via Venmo, please contact us for Venmo information.

Though this show is not an invitational, we will maintain the highest standards of tattooing, therefore, anyone applying to attend the show for the first time will be required to submit their IG portfolio for review by a panel of Professional Tattooers prior to registration being accepted.

Deadline for contracts is Wednesday, May 1, 2024!!

Please be sure to include the name, email, website, Instagram and phone number for ALL tattooers working in the booth! We want to be sure that everyone gets listed on the website, plugs on Instagram and receives all information and important updates about the convention!

*To avoid any issues with social media posts, if you'd like to be posted to the convention Instagram, please create your own collage/post and be sure to tag **@208tattoofest**. We will repost it shortly after we receive the notification. We will post some banners and collage skins/logo for your use.*

All persons conducting business must register with the Idaho State Tax Commission. This is required even if you are not selling merchandise. You will be required to present your Idaho Tax Registration at check in. Failure to register will result in denial of setting up, and no refund will be issued. We will send Tax registration information separately.

As we get closer to the event, more extensive information about the schedule, contests, seminars, entertainment, and other events will be provided for you.

***Money for Booths is non-refundable within sixty (60) days of the event. **Money for Weekend Passes is non-refundable.**

Terms & Conditions

- 1.) New needles and tubes must be used for each tattoo/customer. All needles/tubes should be in undamaged, dated (not expired) packages from the manufacturer/supplier. All tubes must be disposable - no metal tubes are to be used and no autoclave will be at the event.
- 2.) Artists must wear disposable gloves (latex, nitrile, vinyl) at all times while tattooing/piercing.
- 3.) It is **IMPERATIVE** that you wash your hands after any tattoo/piercing procedure. Waterless hand sanitizer must be used for this purpose, until you can get to the hand-wash stations!
- 4.) A maximum of two (2) artists are permitted to work out of one (1) booth at any one time. In addition, tattooists are **ONLY** permitted to work out of booths that have been rented specifically for tattooing. Tattooing is **NOT** permitted in vendor booths.
- 5.) Absolutely **NO** tattooing or piercing will be permitted outside the convention area. If you frequently perform procedures of a sensitive or personal nature, please come prepared with your own privacy screen. Also, any piercing must be done behind a privacy screen.
- 6.) Though the minimum age for tattooing in Idaho is 14, this event is 18 and older only. Only customers over the age of 18 may get tattooed at the 208 Tattoo Fest
- 7.) As we want all to have a successful and good event, and no one undercutting others, there will be a \$100 minimum on all tattoos.
- 8.) All Booths and Persons conducting Business must have a valid tax registration from the State of Idaho. This is required even if you are not selling merchandise. Anyone found conducting business without a valid tax registration will be removed from the event. (Instructions for Tax Registration & event ID will be sent separately)
- 9.) No Vendors may set up in an artist booth. If an artist is selling a product they own under their own brand, this is acceptable, however, no other companies or brands may share a booth with an artist or tattoo shop.
- 10.) Excessively loud music will not be permitted. If you are asked to turn down any music in your booth, please do so. Failure to do so will result in removal from the event without refund.
- 11.) Your booth must always be manned during convention hours. All booths should be open and ready for business according to the times listed below. The tattoo room will be cleared and locked by the times indicated. Please judge yourself accordingly and leave a reasonable amount of time to finish any work in progress.

- 12.) Banners/signs are permissible, but they may only be attached to the piping in your stand with the hooks provided. You will be responsible for any damage to piping and/or drapery in your booth.
- 13.) All equipment provided by the convention services company (garbage cans, tables, chairs, electrical equipment, etc.) must **NOT BE REMOVED** from the booth. You will be responsible for any missing equipment.
- 14.) Aside from the items noted in this contract, exhibitors are responsible for all other materials that they deem necessary to conduct business, i.e., utility strips, extra lighting, paper towels, distilled water, etc. We will provide a stencil booth for your use to include printing of designs.
- 15.) All business transactions and the liabilities associated with those transactions are the sole responsibility of the exhibitor and/or customer involved.
- 16.) The convention hall will be cleared and locked during non-convention hours. Security guards will patrol the halls surrounding the convention room overnight. No one will be permitted in the room except in extreme circumstances and unless accompanied by a 208 Tattoo Fest staff member. These measures are taken to ensure the safety of the people in attendance and property present at this event. **208 Tattoo Fest assumes no liability whatsoever for any accident, injury, damage, or loss caused to any person or property, arising directly or indirectly from this event.**

In signing this contract, I have read, understand and agree to comply to all terms stated herein. Failure to comply is grounds for dismissal from event. No refund shall be given under such circumstances. I understand that 208 Tattoo Fest & Algin Enterprises LLC is in no way liable for any accident, injury, damage or loss, caused to any person or property, arising directly or indirectly from said event.
