#### **Nominations and Election of Local Union 301 IBEW**



The nominations for officers of local union 301 will be held on May 27, 2025, located at 114 Elm Street Nash, TX at 7:00 p.m.

Nominations will proceed in the order of offices as listed in the IBEW Constitution. The term of office shall be 3 years:

- 1. Business Manager / Financial Secretary / Delegate to the International Convention
- 2. President
- 3. Vice President
- 4. Treasurer
- 5. Recording Secretary
- 6. Executive Board (Consist of 5 Members, 3 in Construction Trade)
- 7. Alternate Delegate to the International Convention
- 8. Election Board (to be formed after the close of nominations)

#### Qualifications for running for office include:

1.No member shall be eligible for office unless they have been a member of Local union 301 in continuous good standing for at least **2 years** immediately prior to nominations.

2. No Apprentice shall be eligible to hold office.

3.No member shall be nominated for office unless he or she is present or signify willingness in writing

No member may be a candidate for more than one office.

Anyone nominated to more than one office must choose the office for which they will be a candidate.

The Election shall be conducted by mail ballots, and ballots shall be counted beginning at 3:00 p.m. on June 23, 2025. All members in good standing shall be mailed a ballot not less than 15 days prior to the above specified date.

Ballots received after 3 p.m. on June 23, 2025, will not be counted.

In the event a runoff election is required it shall be held July 21, 2025, under the same rules.

All officers shall be installed and begin their 3 - year term at the regular meeting of Local Union 301 on June 23, 2025
