#### **PROGRAM TERMS**

- Points for the 2026 trip accrue on qualifying purchases made at TML from January 1 thorough December 31, 2025. To qualify for the first trip ticket, a contractor must achieve a minimum of \$200K in total sales with TML.
- Of that \$200K, at least \$90K must be spent on unitary equipment from ICP or Nordyne.
- The trip cost is based on double occupancy, meaning a contractor must reach \$400K in total sales with TML to earn two tickets at no charge.
- If a contractor reaches \$350K in total sales, the remaining \$50K is used to calculate the buy-in cost for the second ticket.
- If you qualify to buy in for a second ticket, you will be responsible for the extra cost (1 per point). This cost is determined using a 0.027 predetermined multiplier Example: \$50,000 x 0.027 = \$1,350 (buy-in cost for the second ticket). Note: you must earn the first trip to be able to buy in the second ticket.
- You will be invoiced for these points in January 2026 for the trip to Punta Cana. Points are cumulative, cannot run into another year and first ticket points must be earned in order to buy into the second ticket. Participants are responsible for all required travel documents.
- TML may amend these terms at any time.

- TML may, at its sole discretion, cancel the trip
  program or change the destination for any reason
  it deems appropriate, including but not limited
  to: escalation of costs and expenses, economic
  conditions, acts of war, force majeure and acts of God.
- To remain eligible, you must be a ICP or Nordyne dealer at the time of the trip.
- Round-trip air fare is included from Toronto. Points cannot be used for upgrades, trip extensions or additional travellers.
- Your account must remain in good standing (prompt monthly payments) until the trip date.
   Invoices not paid according to the dealer's normal terms will not accrue points.
- TML will issue a T4A form for the value of the trip.
   The customer is responsible for any applicable taxes.
   Each trip is based on double occupancy.
- Points are redeemable solely for the TML Dealer Trip Program.
- Points and trips have no cash or monetary value.
   Points may only be redeemed for trip dates listed.

#### **Additional Notes:**

- All contractors, regardless of buy-in status, must pay a \$300 deposit per ticket.
- Solo attendees are subject to a single occupancy premium.
