**SECOND AMENDMENT TO
DECLARATION OF COVENANTS, CONDITIONS AND
RESTRICTIONS FOR SOUND HAMMOCK, A SUBDIVISION**

THIS SECOND AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS is made by the undersigned lot Owners of Sound Hammock, A Subdivision, hereinafter referred to as "Owners,"

WITNESSETH:

WHEREAS, the Declaration of Covenants, Conditions and Restrictions of Sound Hammock were made on October 14, 1999 and recorded in Official Records Book 1788 at Page 957 of the public records of Santa Rosa County, Florida; and

WHEREAS, the First Amendment to the Declaration of Covenants, Conditions and Restrictions Sound Hammock Subdivision were made on June 21, 2000 and recorded in Official Records Book 1834 at Page 985 of the public records of Santa Rosa County, Florida; and

WHEREAS, the Owners desire further to amend the Declaration, and being the holders of not less than two-thirds (2/3) of the votes of the lot Owners are legally entitled to do so,

NOW THEREFORE, Owners amend the Declaration as follows:

1. Article IX, Section 3 is hereby amended to read as follows:

Section 3. Amendment. The covenants and restrictions of this Declaration shall run with and bind the land for a term of thirty (30) years from the date this Declaration is recorded, after which time they shall be extended automatically for successive periods of ten (10) years. This Declaration may be amended by the affirmative vote of two-thirds (2/3) of the Lot Owners (in accordance with the voting rights specified in Article III, above).

2. Section 11.6 of the Exhibit B to the Declaration is hereby amended to read as follows:

b. Square Feet of Living Area Minimum Requirements. All Waterfront Lots 21-35, Block "D" with two or more dwelling levels shall have a minimum square footage requirement of 2,250 square feet. All other units shall have a minimum square footage requirement of 1,800 square feet.

3. Section 5 of Exhibit B to the Declaration is hereby amended to read as follows:

Section 5. Mailbox. Each lot shall use the Williamsburg cast aluminum mailbox, Series 1023A as its Mailbox. (An example of said Mailbox shall be found in Attachment A to this Amendment.) Each Lot Owner shall place 3" Brass Numbers on each side of the Mailbox, representing their street number. Attachments 2 & 3 are hereby deleted.

4. In all other respects, except as amended hereby, the Declaration is ratified and confirmed, and shall remain in full force and effect.
