## Bagwell, J., Edeburn, E. New Faculty Belongingness

**Conceptualization:** New faculty members represent a substantial investment for any university, and the attrition of these faculty can negatively impact the university and the faculty members who do not achieve tenure. To retain tenure-track faculty, especially faculty of color, universities need to examine and understand the relationship between belongingness and the Research, Tenure, and Promotion process, and how these two factors may impact the retention of tenure-track faculty of color.

## Bagwell, J., Flores, C. Social Justice Leadership for All Students: Implications for Educational Leadership and Preparation Programs

Conceptualization of a literature review: There is a growing body of literature on social justice leadership at a time when many of our nation's schools reflect the growing number of students of color and marginalized students. Perhaps the time has come to examine the connections between social justice and inclusion with students of disabilities, and how social justice leadership should be defined more broadly than in the past given the current realities of student populations. There are possible programmatic implications for educational leadership preparation programs.
